ELECTIONS/DATES: Requests a study on the number of Louisiana election dates

1	A STUDY REQUEST
2	To request the House Committee on House and Governmental Affairs to study the
3	possibility of reducing the number of elections held in Louisiana and to report its
4	findings to the House of Representatives prior to the convening of the 2025 Regular
5	Session.
6	WHEREAS, many Louisianans have expressed the view that there are too many
7	dates for elections in this state; in 2023, there were seven election dates held over the course
8	of the year; and
9	WHEREAS, a large number of election dates has numerous detrimental effects on
10	the state and on the efficient operation of representative democracy more generally; and
11	WHEREAS, voter interest and participation in elections tends to decline when there
12	are too many elections; voter turnout in local and special elections is frequently very low;
13	and
14	WHEREAS, there is a cost associated with each election; though holding elections
15	is certainly a valid expense for any government, there are many other valid claims on the
16	public fisc, so it is a concern if the state is spending more than necessary conducting
17	elections; and
18	WHEREAS, elections require human and technological resources, and there is a
19	point at which those resources are over-taxed; frequent elections may encroach upon the
20	time required for proper attention to regular maintenance of voting machines, and elections

1	professionals who are constantly shifting focus from one election to the next can be placed
2	under undue stress when there are more demands than time to meet those demands; and
3	WHEREAS, questions about whether there is an appropriate number of elections are
4	important because the trust Americans have in the legitimacy of their democratic
5	government is dependent on their faith in the legitimacy of its elections and their willingness
6	to participate in those elections; numerous elections with very little to vote on can lead to
7	voter disengagement; and
8	WHEREAS, Louisiana's election cycles are governed by constitutional and statutory

9	provisions and a reduction in the number of elections will require statutory or constitutional
