has any location of its underground utilities or facilities or equipment identified or mapped in connection with the deployment of the broadband projects throughout the state utilizing the funding pursuant to R.S. 51:2370.1, et seq., the Rural Digital Opportunity Fund, the Enhanced Alternative Connect America Model, the Rural Development Broadband ReConnect Program, or any other similar program included in the Broadband Equity Access and Deployment program shall become a member of, participate in, and share the cost of a regional notification center pursuant to R.S. 40:1749.14.

B. Nothing in this Part shall affect any permitting process granted to a parish, municipal, local, or state governing authority. If a permit is issued in conjunction with excavation or demolition subject to the provisions of this Part, upon issuing the permit, the governing authority is encouraged to distribute to the permittee information regarding compliance with the provisions of this Part. The regional notification centers shall provide furnish the information to the governing authority for distribution. The failure of the governing authority to distribute furnish the information shall not for that reason alone create any liability on the part of the governing authority or permittee nor otherwise reduce or limit the duties and responsibilities of excavators or demolishers under this Part.
