| 12 | legislature shall be deposited into the fund. |
| 13 | C. All unexpended and unencumbered monies in the fund at the end of |
| 14 | the fiscal year shall remain in the fund. The monies in the fund shall be invested |
| 15 | by the state treasurer in the same manner as monies in the state general fund, |
| 16 | and interest earned on the investment of monies in the fund shall be credited to |
| 17 | the fund. |

<u>Proposed law</u> creates the Dyslexia Fund as a special fund in the state treasury. Any money transferred, donated, or appropriated to the fund by the legislature shall be deposited into the fund.

<u>Proposed law</u> provides that the monies in the fund shall remain in the fund at the end of the fiscal year and interest earned on the investment of monies in the fund shall be credited to the fund.

<u>Proposed law</u> provides that subject to appropriation, monies may only be used to fund costs associated with testing and screening of students for dyslexia.

Effective upon signature of the governor or lapse of time for gubernatorial action.
