## HOUSE BILL NO. 904

#### BY REPRESENTATIVE CHENEVERT

EDUCATION: Requires school-level reporting by public schools and postsecondary education institutions on programs related to diversity, equity, inclusion, and belonging and requires the state Department of Education and the Board of Regents to submit summary reports to certain legislative committees

1	AN ACT
2	To enact R.S. 17:2122 and 3996(B)(82) and to repeal R.S. 17:2122 and 3996 (B)(82),
3	relative to education; to require each public school and public postsecondary
4	education institution to submit a report relative to funding and personnel used for
5	programs related to diversity, equity, inclusion, and belonging; to provide for the
6	content of the reports and submission either to the state Department of Education or
7	the Board of Regents, as applicable; to require the department and the board to report
8	to certain legislative committees relative to the reports submitted by the schools and
9	institutions; to provide for definitions; to provide for effectiveness; and to provide
10	for related matters.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. R.S. 17:2122 and 3996(B)(82) are hereby enacted to read as follows:
13	§2122. Disclosure of funding and personnel; programs related to diversity, equity,
14	inclusion, and belonging
15	A.(1) Each public elementary and secondary school and each public
16	postsecondary education institution shall submit a written report of each campus
17	program related to diversity, equity, inclusion, and belonging for the 2021-2022,
18	2022-2023, and 2023-2024 fiscal years by October 31, 2024.

5	differential or preferential treatment of individuals on the basis of such classification.
6	B.(1) Each report shall include, at minimum, the following:
7	(a) The purpose and expected outcome of each program.
8	(b) A brief description of each program.
9	(c) The number of personnel dedicated to the program.
10	(d) The total amount of funding expended to support or implement the
11	program, including salaries, stipends, and benefits.
12	(e) Of the total amount spent to support the program, the amount that is state-
13	funded.
14	(2) Public postsecondary education institutions shall not include programs
15	directly affiliated with Title IX in their reports.
16	C. Each public elementary and secondary school shall submit its report to the
17	state Department of Education, and each public postsecondary education institution
18	shall submit its report to the Board of Regents.
19	D. The department and the board shall each develop a comprehensive written
20	report containing the information reported by each institution, disaggregated by
21	school or institution, as applicable, by system, and by the nature of the program and
22	the funding thereof, and submit its report to the House Committee on Education,
23	Senate Committee on Education, House Committee on Appropriations, and Senate
24	Committee on Finance by December 31, 2024.

26	§3996. Charter schools; exemptions; requirements

28	B. Notwithstanding any state law, rule, or regulation to the contrary and
29	except as may be otherwise specifically provided for in an approved charter, a

1	charter school established and operated in accordance with the provisions of this
2	Chapter and its approved charter and the school's officers and employees shall be
3	exempt from all statutory mandates or other statutory requirements that are
4	applicable to public schools and to public school officers and employees except for
5	the following laws otherwise applicable to public schools with the same grades:

10	Section 2. R.S. 17:2122 and 3996(B)(82) are hereby repealed in their entirety.
11	Section 3.(A) Section 1 and this Section of this Act shall become effective upon
12	signature of this Act by the governor or, if not signed by the governor, upon expiration of
13	the time for bills to become law without signature by the governor, as provided by
14	Article III, Section 18 of the Constitution of Louisiana. If this Act is vetoed by the governor
15	and subsequently approved by the legislature, Section 1 and this Section of this Act shall
16	become effective on the day following such approval.
17	(B) Section 2 of this Act shall become effective on January 1, 2025.

Abstract: Requires each public school and public postsecondary education institution to report on funding and personnel for programs related to diversity, equity, inclusion, and belonging to the state Dept. of Education or Bd. of Regents, as applicable, and requires the department and board to report to certain legislative committees.

<u>Proposed law</u> requires public schools to submit to the state Dept. of Education (DOE) and public postsecondary education institutions to submit to the Bd. of Regents (Regents) a written report of all campus programs related diversity, equity, inclusion, and belonging not later than Oct. 31, 2024, which shall include the following for FY 2021-2022, FY 2022-2023, and FY 2023-2024:

- (1) The purpose and expected outcome of each program.
- (2) A brief description of each program.

- (3) The number of personnel dedicated to the program.
- (4) The total amount of funding expended to support or implement the program, including salaries, stipends, and benefits.
- (5) Of the total amount spent to support the program, the amount that is state-funded.

<u>Proposed law</u> requires DOE and Regents each to submit a comprehensive written report summarizing this information to the House and Senate education committees, House Committee on Appropriations, and Senate Committee on Finance not later than Dec. 31, 2024.

Effective upon signature of governor or lapse of time for gubernatorial action; repeal of proposed law effective Jan. 1, 2025.
