FIRE PROTECT/FIREMEN: Provides for the financial security of surviving spouses and dependent children of deceased firemen in certain circumstances

AN ACT

2	To amend and reenact R.S. 40:1665(B), relative to firefighters; to provide for financial
3	security of certain surviving spouses and children; to provide for applicability to
4	certain firefighters employed by federal agencies; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. This Act shall be known and may be cited as the "Fire Chief T.J. Maury
7	Act".
8	Section 2. R.S. 40:1665(B) is hereby amended and reenacted to read as follows:
9	§1665. Financial security for surviving spouses and children of firemen in certain
10	cases

12	B. Firemen, within the meaning of this Section, shall include all paid,
13	regularly employed firemen and all volunteer firemen of any municipality, parish,
14	federally or state- recognized Indian tribe or tribal unit, or fire protection district
15	maintaining a fire department, or of any volunteer fire department. Firemen shall
16	also include any firefighter employed by or under the control of one of the following
17	federal agencies if the injury resulting in death occurred in Louisiana: the
18	Department of Defense, the Department of Veterans Affairs, the Department of

1 Agriculture, the Department of the Interior, or the Federal Emergency Management

4 Section 3. The provisions of R.S. 40:1665(B) as amended by this Bill shall be

applied retroactively to August 1, 2023.

Abstract: Provides for the financial security of surviving spouses and dependent children of a firefighter employed by certain federal agencies and killed in the line of duty.

<u>Present law</u> provides for payment of \$250,000 to the surviving spouse, child, or other beneficiary of a fireman who suffers death as a result of an injury arising out of and in the course of the performance of his official duties or arising out of any activity in his capacity as a fireman in the protection of life and property. Specifies the paid and volunteer firemen to whom <u>present law</u> is applicable.

<u>Proposed law</u> expands the applicability of <u>present law</u> to include any firefighter employed or under the control of one of the following federal agencies if the injury that resulted in the death occurred in La.:

- (1) Dept. of Defense.
- (2) Dept. of Veterans Affairs.
- (3) Dept. of Agriculture.
- (4) Dept. of the Interior.
- (5) Federal Emergency Management Administration.

Proposed law applies retroactively to Aug. 1, 2023.

(Amends R.S. 40:1665(B))

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Municipal, Parochial and Cultural Affairs</u> to the <u>original</u> bill:

- 1. Name the bill the "Fire Chief T.J. Maury Act".
- 2. Add provision for retroactive application.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

The House Floor Amendments to the engrossed bill:

1. Make <u>proposed law</u> applicable to firefighters employed by or under the control of the U.S. Dept. of Veterans Affairs.
