Proposed legislation requires firemen to complete and pass a certified firemen's training program from a Pro Board accredited agency or the International Fire Service Accreditation Congress (IFSAC) for purposes of receiving state supplemental pay. Proposed legislation removes certification from training programs approved by the office of the state marshal Fire and Emergency Training Academy for purposes of receiving supplemental pay.
