CONDOLENCES: Expresses condolences of the House on the death of Roena Isabelle Wilford

A RESOLUTION

2	To express the condolences of the House of Representatives upon the death of Roena
3	Isabelle Wilford.
4	WHEREAS, Roena Isabelle Wilford was the ninth child born to Louis Wendell
5	Wilford and Mollie Jean Alexander Wilford; she was baptized at an early age under the
6	leadership of Reverend R.L. Burden at Mt. Carmel Baptist Church in Baton Rouge; and
7	WHEREAS, Roena's life was historically significant to the country and the Baton
8	Rouge community; in 1956, she and four of her siblings were selected to be the first African
9	American students to integrate the Baton Rouge public school system, and they were listed
10	as plaintiffs in the Brown v. Board of Education case; and
11	WHEREAS, Roena attended four different schools by the time she reached fifth
12	grade; in eighth grade, she transferred to Southern University Laboratory School with her
13	older siblings and joined the cheerleading and track teams; she remained at the school until
14	her graduation in 1967, having been the senior class parliamentarian; and
15	WHEREAS, despite receiving an offer to study at Ithaca College in New York,
16	Roena chose to enroll at Southern University and A&M College; she majored in secondary
17	education and was a member of several organizations, including the Kappa Delta Education
18	Honors Society, Alpha Kappa Interdisciplinary Honors Society, and Association of Women
19	Students; and
20	WHEREAS, Roena was initiated into the Beta Psi Chapter of Alpha Kappa Alpha
21	Sorority, Inc., in 1969, and she served as the chapter president in 1970; she also served as

2	office held by an undergraduate in the organization; and
3	WHEREAS, Ms. Wilford became Southern University's first-ever female Student
4	Government Association president and served for the 1970-1971 school year; during her
5	tenure, she introduced the school's first student loan program, and her administration was the
6	first to give Miss Southern a \$200 stipend; and
7	WHEREAS, Ms. Wilford graduated summa cum laude with a bachelor's degree in
8	secondary education from Southern University on May 31, 1971; after graduating, she
9	began a contract with the East Baton Rouge Public School System; she also enrolled at
10	Louisiana State University and completed a master of arts degree in curriculum instruction
11	with an education specialty; and
12	WHEREAS, Ms. Wilford was employed at Baton Rouge Magnet High School, where
13	she taught physics, math, and a course entitled "Man Made World" from August 1971 until
14	May 1972; she then worked for the Louisiana Equal Educational Opportunity Department
15	for three-and-a-half years before moving to Boston, Massachusetts, where she served as
16	coordinator of the Lena Parks Corporation; and
17	WHEREAS, on February 16, 1980, Roena chartered the Nu Gamma Omega Chapter
18	of Alpha Kappa Alpha Sorority, Inc., in the Baton Rouge community; and
19	WHEREAS, Roena moved to Louisville, Kentucky, where she worked as a personnel
20	supervisor for Capital Holding Corporation of Louisville; she also volunteered with the Girl
21	Scouts of Kentucky and attended First Baptist Church of Jeffersontown, where she taught
22	preschool Sunday school, served as an assistant chaplain for one of the church choirs, taught
23	a youth church doctrine class, and chaired the youth social activity committee; she was also
24	selected as the 1981 Outstanding Woman of the Year for her work in both Baton Rouge and
25	Louisville; and
26	WHEREAS, Ms. Wilford returned to Baton Rouge in 1983 and began working at
27	Southern University, where she served as a physics instructor until her health-required
28	retirement in 2004; after retiring, she continued her community service by remaining
29	actively involved in Girl Scouts, Mt. Carmel Baptist Church, and the Nu Gamma Chapter
30	of Alpha Kappa Alpha Sorority, Inc.; she also volunteered at Winbourne Elementary School,

the 2nd National Vice President of Alpha Kappa Alpha Sorority, Inc., which is the highest
