Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

HEALTH CARE. Provides relative to health care definitions. (8/1/25)

1 AN ACT

2 To amend and reenact R.S. 40:1151.1(6) and 1231.1(A)(9), (10), and (13), relative to health  
3 care definitions; to provide for definitions relative to medical malpractice; to provide  
4 for definitions relative to declarations concerning life-sustaining procedures; and to  
5 provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 40:1151.1(6) and 1231.1(A)(9), (10), and (13) are hereby amended  
8 and reenacted to read as follows:

9 §1151.1. Definitions

10 As used in this Subpart, the following words shall have the meanings  
11 ascribed to them unless the context clearly states otherwise:

13 (6) "Health care provider" means any health maintenance organization, home  
14 health agency, hospice, hospital, ~~or~~ nursing facility, or any entity listed in R.S.  
15 40:1231.1(10).

17 §1231.1. Definitions and general applications

1 A. As used in this Part:

2 \* \* \*

3 (9) "Health care" means any act, ~~or treatment,~~ **administration, service, or**  
4 **care related to policies and procedures and the administration thereof, staffing,**  
5 **custodial services by licensed or certified staff,** performed or furnished, or which  
6 should have been performed or furnished, by any health care provider for, to, or on  
7 behalf of a patient during the patient's medical care, treatment, or confinement, or  
8 during or relating to or in connection with the procurement of human blood or blood  
9 components. **This includes all acts associated with the medical treatment of an**  
10 **individual, whether directly related to clinical care or performed in an**  
11 **administrative, managerial, or supporting capacity necessary for the delivery**  
12 **of such care.**

13 (10) "Health care provider" means a person, partnership, limited liability  
14 partnership, limited liability company, corporation, facility, or institution licensed  
15 or certified by this state, **state agencies, or the board** to provide health care or  
16 professional services as a physician, hospital, nursing home, community blood  
17 center, tissue bank, dentist, a licensed dietician or licensed nutritionist employed by,  
18 referred by, or performing work under contract for, a health care provider or other  
19 person already covered by this Part, registered or licensed practical nurse or certified  
20 nurse assistant, offshore health service provider, ambulance service under  
21 circumstances in which the provisions of R.S. 40:1237.1 are not applicable, certified  
22 registered nurse anesthetist, nurse midwife, licensed midwife, nurse practitioner,  
23 clinical nurse specialist, pharmacist, optometrist, podiatrist, chiropractor, physical  
24 therapist, **physical therapist assistant,** occupational therapist, **occupational**  
25 **therapist assistant,** psychologist, social worker, licensed professional counselor,  
26 licensed perfusionist, licensed respiratory therapist, licensed radiologic technologist,  
27 licensed clinical laboratory scientist, **administrator,** or any nonprofit facility  
28 considered tax-exempt under Section 501(c)(3), Internal Revenue Code, pursuant to  
29 26 U.S.C. 501(c)(3), for the diagnosis and treatment of cancer or cancer-related

1 diseases, whether or not such a facility is required to be licensed by this state, or any  
2 professional corporation a health care provider is authorized to form under the  
3 provisions of Title 12 of the Louisiana Revised Statutes of 1950, or any partnership,  
4 limited liability partnership, limited liability company, management company, or  
5 corporation ~~whose business is conducted principally by health care providers~~ which  
6 may provide any kind of health care whatsoever, or an officer, employee, partner,  
7 member, shareholder, or agent thereof acting in the course and scope of his  
8 employment.

10 (13) "Malpractice" means any unintentional tort or any breach of contract,  
11 regardless of theory of liability, based on health care or professional services  
12 rendered, or which should have been rendered, by a health care provider, to a patient,  
13 including but not limited to failure to render services timely and the handling of a  
14 patient, ~~including~~ loading and unloading of a patient, and ~~also includes~~ all legal  
15 responsibility of a health care provider arising from acts or omissions during the  
16 procurement of blood or blood components, in the staffing, training, or supervision  
17 of health care providers, or from defects in blood, tissue, transplants, drugs, and  
18 medicines, or from defects in or failures of prosthetic devices implanted in or used  
19 on or in the person of a patient. This includes all acts associated with the medical  
20 treatment of an individual, whether directly related to clinical care or  
21 performed in an administrative, managerial, or supporting capacity necessary  
22 for the delivery of such care.

Proposed law changes the definition to align with the definition of "health care provider" in the Medical Malpractice Act.

Effective August 1, 2025.
