23	body of rugby, World Rugby or USA Rugby including but not limited to World

27	(bb) Any event sanctioned by the Association of Tennis Professionals or
28	Women's Tennis Association, including events on the ATP Tour or WTA Tour.
29	(cc) Any event sanctioned by the Professional Rodeo Cowboys
30	Association, Professional Bull Riders, or any international amateur or
31	professional rodeo or bull riding event."

7 8 9	G. <u>H.</u> Louisiana Economic Development shall promulgate rules for the administration of the program in accordance with the Administrative Procedure Act. In order to expedite implementation of the program, the department shall utilize
10	emergency rulemaking for the promulgation of the initial administrative rules."
11	AMENDMENT NO. 11
12	On page 3, between lines 23 and 24 insert the following:
13	"§1261. Events Incentive Fund
14	A.(1) There is hereby created in the state treasury, as a special fund, the
15	Events Incentive Fund, hereinafter referred to in this Section as the "fund".
16	(2) The source of monies deposited into the fund shall be any monies
17	appropriated by the legislature, including federal funds, any public or private
18	donations, gifts, or grants from individuals, corporations, nonprofit
19	organizations, or other business entities which may be made to the fund, and
20	any other monies which may be provided by law.
21	(3) Monies in the fund shall be invested in the same manner as monies
22	in the state general fund and any interest earned on the investment of monies
23	in the fund shall be credited to the fund. All unexpended and unencumbered
23	monies in the fund at the end of the fiscal year shall remain in the fund.
25	(4) Monies in the fund shall be used solely for attracting, planning,
26	marketing, and conducting events pursuant to the Events Incentive Program as
20	provided in this Section.
28	B. There is hereby created the Events Incentive Program, hereinafter
28 29	referred to in this Section as the "program", to be administered by Louisiana
30 31	Economic Development in accordance with rules and regulations. The program shall provide grant funding to municipalities, parishes, official tourism
32	commissions, convention and visitors bureaus, official destination marketing
32 33	organizations, and nonprofit corporations hosting an event for costs associated
33 34	with planning, marketing, and conducting events held in Louisiana.
35	C. An entity shall be eligible to receive funding through the program
36	only if all of the following apply:
30 37	(1) The event is not a "qualified major event" as defined in R.S. 51:1260.
38	(2) The event is not held more than one time per year in Louisiana or
39	any other state. The provisions of this Paragraph shall not apply to events
40	occurring twice in one year due to a natural disaster, an act of God, force
40 41	majeure, a catastrophe, pandemic, or such other occurrence which causes the
42	event to move or be rescheduled.
43	(3) The applicant submits the application and required documentation
44	no later than one hundred eighty days prior to the event. The documentation
44	shall include:
46	(a) The total anticipated cost of the event.
47	(b) The amount and anticipated sources of funding for the event.

48 49	(c) An economic impact analysis conducted by an economist selected by Louisiana Economic Development indicating the event has an anticipated
49 50	impact of three hundred fifty thousand dollars or greater to the state.
50 51	(d) A proposal for the utilization of the grant funding.
52 53	D. A municipality, parish, or nonprofit corporation hosting the event shall be aligible to receive up to twenty five percent of the total entipineted cost
53 54	shall be eligible to receive up to twenty-five percent of the total anticipated cost
54	incurred by the entity for the event, not to exceed two hundred fifty thousand
55	<u>dollars per grant.</u>
56	E. Any grants received pursuant to this Section may be used for either
57	of the following:
58	(1) To pay or reimburse the costs of applying or bidding for selection as
59	the site of the event.

1	(2) To pay or reimburse the costs of planning, marketing, or conducting
2	the event.
3	F. The secretary of Louisiana Economic Development shall select grant
4	recipients and is hereby authorized to enter into a contract with an event
5	producer or host, a local organizing committee, endorsing parish, endorsing
6	municipality, official tourism commission, convention and visitors bureau, or
7	official destination marketing organization to provide grant funding in
8	accordance with the provision s of Subsection E.
9	G. No later than September first of each year, the secretary of Louisiana
10	Economic Development shall submit an annual report on the program to the
11	Joint Legislative Committee on the Budget. The report shall include the entities
12	that received grant funding for events in the previous fiscal year pursuant to
13	this Section and the economic impact of the events to the state, to the extent
14	possible.
15	H. Louisiana Economic Development shall promulgate rules for the
16	administration of the program in accordance with the Administrative
17	Procedure Act."
