HOUSE CONCURRENT RESOLUTION NO. 24

BY REPRESENTATIVE MIKE JOHNSON

SCHOOLS/HIGH SCHOOL: Creates a special committee of the legislature to study the Louisiana High School Athletic Association (LHSAA)

## 1 A CONCURRENT RESOLUTION

2 To create a special committee of the legislature to conduct a comprehensive study of the  
3 Louisiana High School Athletic Association's policies, governance structure, and  
4 impact on public schools and to provide for the special committee's submission of  
5 a report to the House Committee on Education and the Senate Committee on  
6 Education not later than February 14, 2026.

7           WHEREAS, the Louisiana High School Athletic Association (LHSAA) plays a  
8   significant role in regulating interscholastic athletics in the state, affecting student-athletes,  
9   school employees, and public institutions; and

10 WHEREAS, questions have been raised regarding the transparency, fairness, and  
11 ethical considerations of LHSAA's policies, including but not limited to school  
12 classifications, transfer rules, academic priorities, and the organization's overall governance;  
13 and

14 WHEREAS, concerns exist regarding the potential appearance of conflicts of interest  
15 between LHSAA and public school officials, including teachers, principals, and other  
16 employees who may have decision-making authority over school athletics; and

17 WHEREAS, the economic impact of LHSAA membership on public schools,  
18 including costs, benefits, and financial obligations, warrants a thorough review in terms of  
19 whether such an association serves the best interests of Louisiana's student-athletes and  
20 taxpayers; and

1           WHEREAS, it is in the interest of the state of Louisiana to provide that the  
2   governance of high school athletics is conducted in a manner that is fair and equitable to all  
3   public schools, students, and employees; and

4           WHEREAS, all policies governing student-athletes should align with academic  
5   priorities and foster an environment that places education at the forefront.

6           THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
7   create a special committee of the legislature to conduct a comprehensive study of the  
8   Louisiana High School Athletic Association's policies, governance structure, and impact on  
9   public schools.

10          BE IT FURTHER RESOLVED that the special committee shall have the following  
11   ten members:

12           (1) The speaker pro tempore of the House of Representatives.

13           (2) The president pro tempore of the Senate.

14           (3) The chairman of the House Committee on Education or a member of the House  
15   designated by the chairman.

16           (4) Four additional members of the House appointed by the chairman of the House  
17   Committee on Education.

18           (5) The chairman of the Senate Committee on Education or a member of the Senate  
19   designated by the chairman.

20           (6) Two additional members of the Senate appointed by the chairman of the Senate  
21   Committee on Education.

22          BE IT FURTHER RESOLVED that the chairman and vice chairman shall be elected  
23   by a majority of the committee members present and voting at its first meeting.

24          BE IT FURTHER RESOLVED that the special committee shall:

25           (1) Review LHSAA rules and regulations as well as any contracts and agreements  
26   between LHSAA and the state, any of its political subdivisions, and any public schools.

27           (2) Examine the potential appearance of conflicts of interest between LHSAA and  
28   public officials, school administrators, and employees.

1           (3) Analyze LHSAA policies related to academic priorities, transfer rules, and  
2 school classification for purposes of discussing their fairness, consistency, and impact on  
3 student-athletes and public schools.

4           (4) Discuss whether LHSAA's governance practices are fair and equitable to all  
5 public schools, students, and school employees.

6           (5) Explore the financial costs and benefits of LHSAA membership for public  
7 schools, including financial obligations and revenue-sharing models.

8           (6) Explore alternative governance models for the administration and oversight of  
9 high school athletics to determine if alternative structures might better serve public school  
10 students and institutions.

11          (7) Review any relevant state laws regarding public school athletics and the  
12 association's authority and consider the recommendation of legislation in the effort to  
13 provide a fair, transparent, and academically focused athletic system.

14          BE IT FURTHER RESOLVED that the special committee shall have the same power  
15 and authority granted to standing committees to hold hearings, subpoena witnesses,  
16 administer oaths, require the production of books and records, and to do all other things  
17 necessary to accomplish the purposes of its study in accordance with the Rules of Order of  
18 the House of Representatives.

19          BE IT FURTHER RESOLVED that the special committee shall be active from  
20 July 1, 2025, through February 14, 2026, and shall submit a report of its findings and  
21 recommendations to the House Committee on Education and the Senate Committee on  
22 Education not later than February 14, 2026.

23          BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the  
24 executive director of the Louisiana High School Athletic Association and the state  
25 superintendent of education.

Creates a special committee of the legislature to study the La. High School Athletic Association (LHSAA). Provides for the following 10 members:

- (1) The speaker pro tempore of the House of Representatives.
- (2) The president pro tempore of the Senate.
- (3) The chairman of the House Committee on Education or a member of the House designated by the chairman.
- (4) Four additional members of the House appointed by the chairman of the House Committee on Education.
- (5) The chairman of the Senate Committee on Education or a member of the Senate designated by the chairman.
- (6) Two additional members of the Senate appointed by the chairman of the Senate Committee on Education.

Provides for study components and for submission of a report to the House and Senate education committees by Feb. 14, 2026.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by House Committee on Education to the original resolution:

1. Increase the committee membership from eight to 10 by granting two additional appointees to the chairman of the House Committee on Education.
