2	To express the condolences of the House of Representatives upon the death of Ayodele
3	"Ayo" Edith Anderson.
4	WHEREAS, it is with immense sadness and profound regret that the House of
5	Representatives of the Legislature of Louisiana has learned of the passing, on Friday,
6	April 25, 2025, of Ayodele "Ayo" Edith Anderson; and
7	WHEREAS, Ayo was born on May 23, 1976, in Columbus, Ohio, to Arthur Lee and
8	Burnadine Moss Anderson; she grew up in Shreveport, Louisiana, where she was baptized
9	at Stoner Hill Baptist Church in 1984 and grew in her faith at Mount Canaan Baptist Church;

11	WHEREAS, Ayo was a member of the inaugural kindergarten class at South
12	Highlands Elementary Magnet School, and she attended Caddo Middle Magnet School and
13	C.E. Byrd High School; she enrolled at Southern University and A&M College in Baton
14	Rouge, Louisiana, in 1994, and followed her mother's legacy by pledging "Service to All
15	Mankind" at her spring 1996 initiation into the Beta Psi Chapter of Alpha Kappa Alpha
16	Sorority, Incorporated (AKA); and
17	WHEREAS, Ayo was an incredibly gifted scholar who excelled in her academic
18	pursuits; she graduated cum laude from the Southern University Honors College and
19	received a bachelor of arts degree in mass communications and media studies in 1998; and
20	WHEREAS, Ms. Anderson returned to Shreveport after graduating and launched her
21	communications career at Southern University at Shreveport; she quickly gained recognition

1	as a rising civic and business leader through her involvement with the Greater Shreveport
2	Chamber of Commerce's Leadership Shreveport Program; after one year, she moved to New
3	York to attend graduate school at Syracuse University, where she earned a master's degree
4	from the prestigious S.I. Newhouse School of Public Communications; and
5	WHEREAS, Ms. Anderson began a successful corporate career in New York,
6	working as a human resources manager for Verizon in New York City; in this role, she
7	managed company priorities in the areas of diversity, supplier diversity, EEO compliance,
8	and talent acquisition, and she earned the National Award for Employee Innovation in
9	recognition of her outstanding contributions; she thrived in the city, building a wonderful
10	community of friends in Brooklyn and becoming a faithful member of Emmanuel Baptist
11	Church; and
12	WHEREAS, Ayo relocated to Lewisville, Texas, for work in 2005 and became a
13	devoted member of Concord Baptist Church; she lived out her passion for service through
14	her involvement with the Omicron Mu Omega Chapter of AKA and the Trinity Chapter of
15	The Links, Incorporated; she took on leadership roles within AKA, serving as chairman of
16	Founders' Day in 2024 and 2025 and chairman of the chapter's membership committee; she
17	led the organization's South Central Regional Hospitality Committee for four years; and
18	WHEREAS, Ayo returned to Shreveport to care for her family and continued serving
19	the community as the chaplain for both the Shreveport Chapter of The Links, Incorporated,
20	and the Red River Chapter of Jack and Jill of America, Incorporated; she worked with the
21	Area Health Education Center at LSU Health Shreveport and mentored young scholars
22	pursuing careers in healthcare, particularly those serving rural and underserved communities;

24	WHEREAS, Ms. Anderson fulfilled her dream of being a small business owner by
25	launching Ayo's Exquisite Excursions and Events; through her business, she showcased her
26	entrepreneurial talents and passion for curating unforgettable experiences; and
27	WHEREAS, Ayodele "Ayo" Edith Anderson leaves to cherish her beautiful memory
28	her son and best friend, Ayden Akil Moss Anderson; mother, Burnadine Moss Anderson;
29	brothers, Dakarai Akil Anderson, Calvin Jermaine Hall, Sr. (Tina), and Derrick Hall (Lisa);
30	uncles, Leo Anderson, Cato Stephens, Kenneth Webb (Yolanda), and Marshall Webb, Jr.;
