Amendments proposed by Representative Illg to Engrossed House Bill No. 580 by Representative Illg

1 AMENDMENT NO. 1

2 On page 1, line 2, after "521," delete the remainder of the line and at the beginning of line
3 3 delete "paragraph) and (2) and (7)"

4 AMENDMENT NO. 2

5 On page 1, line 12, after "521" delete the remainder of the line and on line 13 delete
6 "paragraph) and (2) and (7)"

7 AMENDMENT NO. 3

8 On page 6, line 6, after "Paragraph" delete the remainder of the line and insert "(1) of this
9 Subsection."

10 AMENDMENT NO. 4

11 On page 6, delete line 10 in its entirety and insert "(1) of this Subsection."

12 AMENDMENT NO. 5

13 On page 6, line 13, after "Paragraph" delete the remainder of the line and delete line 14 in
14 its entirety and insert "(1) of this Subsection."

15 AMENDMENT NO. 6

16 On page 6, delete line 20 in its entirety and insert the following:

17 "(1) To operate, or for the owner thereof knowingly to permit the operation
18 of any motor or other vehicle, trailer or semi-trailer, which is not registered or which
19 does not have attached thereto and displayed thereon, in accordance with the
20 provisions of R.S. 47:507, the number plates assigned to it for the current year,
21 subject to the exemptions provided in this Chapter."

22 AMENDMENT NO. 7

23 On page 6, delete line 25 in its entirety and insert the following:

24 "(3) To lend to or knowingly permit the use of by any one not entitled
25 thereto, any registration number plate issued to the person so lending or permitting
26 the use thereof.

27 (4) To fail or refuse to surrender to the commissioner or officers of the
28 Division of State Police, upon demand, any registration certificate or registration
29 number plate which has been suspended, cancelled or revoked, as provided in this
30 Chapter.

1 (5) To use a false or fictitious name or address in any application for the
2 registration of any vehicle or for any renewal or duplicate thereof, or to make a false
3 statement or knowingly to conceal a material fact or otherwise commit a fraud in any
4 such application.

5 (6) For the owner, purchaser, assignee or transferee of a vehicle formerly
6 registered in the name of another, to neglect, fail or refuse to surrender to the
7 commissioner or officer of the Division of State Police the registration certificate of
8 the former owner, or to fail or refuse to furnish the commissioner with satisfactory
9 proof as to the transfer thereof and his ownership of the vehicle."

10 AMENDMENT NO. 8

11 On page 6, between lines 28 and 29 insert the following:

12 "(8) To obtain or use an improper registration certificate, license or license
13 plates, or to make improper use of a properly obtained registration license or license
14 plate, or to use upon one vehicle the license plates issued for another vehicle, or to
15 register and attach license plates to and use on the highways of this State a vehicle
16 unsafe or unfit to be operated, or one that is not equipped as required by law, or for
17 a manufacturer or dealer to make or permit to be made any unlawful use of the same
18 or permit the use thereof by a person not entitled thereto."

19 AMENDMENT NO. 9

20 On page 6, line 29, after "of" change "this Paragraph" to "Subsection A of this Section"

21 AMENDMENT NO. 10

22 On page 7, delete line 8 in its entirety and insert the following:

23 ~~"(8) To obtain or use an improper registration certificate, license or license~~
24 ~~plates, or to make improper use of a properly obtained registration license or license~~
25 ~~plate, or to use upon one vehicle the license plates issued for another vehicle, or to~~
26 ~~register and attach license plates to and use on the highways of this State a vehicle~~
27 ~~unsafe or unfit to be operated, or one that is not equipped as required by law, or for~~
28 ~~a manufacturer or dealer to make or permit to be made any unlawful use of the same~~
