HOUSE RESOLUTION NO. 15

ATHLETICS: Creates a task force to study issues relative to the name, image, and likeness of student athletes in Louisiana

1	A RESOLUTION
2	To create a task force to study issues relative to the name, image, and likeness of student
3	athletes in Louisiana.
4	WHEREAS, in recent years, name, image, and likeness deals for student athletes
5	have been wrought with confusion and controversy; and
6	WHEREAS, there is often a lack of transparency relative to the income of these
7	athletes; and
8	WHEREAS, opening name, image, and likeness records to the public can create an
9	opportunity to foster knowledge and openness of information, which can help athletes to
10	empower themselves to make wise decisions for their finances and their futures.
11	THEREFORE, BE IT RESOLVED that the House of Representatives of the
12	Legislature of Louisiana does hereby create a task force to study issues relative to the name,
13	image, and likeness of student athletes in Louisiana.
14	BE IT FURTHER RESOLVED that the task force shall be composed of the
15	following members:
16	(1) The member of the House of Representatives who represents House District 11,
17	who shall serve as chairman.
18	(2) One member of the House of Representatives appointed by the speaker of the
19	House.
20	(3) The attorney general or her designee.
21	(4) Six athletic directors, or their designees, two from each of the following systems:
22	Louisiana State University, Southern University, and University of Louisiana, to be
23	appointed by the respective system presidents.

1 (5) Three student athletes, one from each of the following systems: Louisiana State 2 University, Southern University, and University of Louisiana, to be appointed by the 3 respective system presidents. 4 (6) Three members from the private sector, to be chosen by the task force chairman 5 after the first meeting of the task force. 6 (7) The commissioner of higher education or her designee. BE IT FURTHER RESOLVED that the appointing authorities shall submit the names 7 8 and contact information of their appointees to the commissioner of higher education no later 9 than June 1, 2025. 10 BE IT FURTHER RESOLVED that the task force chairman shall call the first meeting no later than August 1, 2025. 11 12 BE IT FURTHER RESOLVED that the Board of Regents shall provide staff support 13 to the task force, to be provided from existing personnel. 14 BE IT FURTHER RESOLVED that members of the task force shall receive no 15 compensation for their services and shall serve at no expense to the state. 16 BE IT FURTHER RESOLVED that the task force shall examine aspects of name, 17 image, and likeness of student athletes in Louisiana, including but not limited to the 18 following: 19 (1) Any existing state and federal laws, jurisprudence, and any relevant national 20 athletic association policies or bylaws regarding a student athlete's use of his name, image,

(2) The documentation and reporting necessary to maintain increased accountability and transparency, as well as possible prevention methods of potential negative consequences

- 13 likeness deals; the report may include suggestions for legislation.
- BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 15 commissioner of higher education.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Education</u> to the original bill:

- 1. Reduce the number of task force members <u>from</u> 20 <u>to</u> 16.
- 2. Require that the representative serving House District 11 serve as chairman and call the first meeting by Aug. 1, 2025.
- 3. Prescribe certain matters related to the name, image, and likeness of student athletes in La. for the task force to study.
- 4. Move the written report submission deadline <u>from</u> 60 days prior to the 2026 R.S. <u>to</u> Jan. 23, 2026.
