WHEREAS, she held a Doctor of Education, exemplifying her unrelenting commitment to learning and teaching, and she used her knowledge to uplift her community and advocate for positive change; and

WHEREAS, her public service also included contributions to Habitat for Humanity and her role as the president of the Stoner Hill Neighborhood Association and was

affectionately known as the "Mayor of Stoner Hill", reflecting a deep-rooted commitment to both housing security and local governance; and
