5 directors of the boards; to provide for duties and responsibilities of the boards; to provide

6 for reporting of the actions of the boards; to provide for monitoring of the boards; and to

- 9 On page 1, delete line 7 in its entirety and insert the following:

"Section 1. R.S. 28:914(D)(1) and 918(A) are hereby amended and reenacted and
 R.S. 28:914(E) is hereby enacted to read as follows:"

- 12 AMENDMENT NO. 3
- 13 On page 1, delete lines 8 through 19 and page 2 in their entirety and insert the following:

14	"D. All district and authority boards shall adopt:
15	(1) A mission, vision, and policy for the operation of the district or authority.
16	The board shall set policy as a body and shall employ an executive director director,
17	subject to confirmation by the secretary and the surgeon general, who shall be
18	accountable to the board, as a body, for the implementation of the policies
19	established by the board.

21	E.(1) Each district and authority board shall complete all of the following:
22	(a) Adopt consistent performance indicators to standardize reporting
23	outcomes.
24	(b) Conduct an assessment evaluating insurance and Medicaid billing to
25	insure optimum billing practices to support self-generated revenue. Each board shall
26	report its findings to the department and make its findings publicly available online.
27	(c) Focus on primary care integration. Each board shall complete the
28	Integration Practice Assessment Tool (IPAT), report its findings to the department,
29	and make its findings publicly available online.
30	(d) Conduct annual patient satisfaction surveys, report its findings to the
31	department, and make its findings publicly available online.
32	(e) Standardize processes and expand strategies to maximize financial
33	viability to reduce reliance on state funding.
34	(f) Prepare an annual report summarizing a board's progress toward
35	achieving statewide health goals as determined by the department.
36	(g) Hold an annual meeting to inform and educate elected individuals and
37	their staffs on the work that the board is completing in its jurisdiction. Each board
38	shall present at an annual meeting held at the state capitol. Each board shall prepare

1	a presentation that includes, at a minimum, the information required by this
2	Paragraph.
3	(2) The report required by Subparagraph (1)(e) of this Subsection shall
4	include but not be limited to all of the following:
5	(a) An overview of programs and initiatives undertaken in the preceding
6	year.
7	(b) Metrics indicating performance and outcomes relative to the statewide
8	health goals including patient surveys.
9	(c) Identified challenges and barriers to progress.
10	(d) Plans for improvement or adjustment in the upcoming year.
11	(3)The department shall compile the reports required by this Paragraph (2)
12	of this Subsection and prepare a statewide summary for submission to the House
13	Committee on Health and Welfare and the Senate Committee on Health and Welfare
14	by February first of each year.

16	§918. Louisiana Department of Health; responsibility and authority to contract;
17	monitor; sanction
18	A. The secretary, upon consultation with the human services districts and
19	authorities, secretary shall be responsible for policy, development, implementation,
20	and monitoring of service provision of the statewide human services system to assure
21	the appropriate and reasonable delivery of behavioral health, intellectual disability,
22	and developmental disability services funded by appropriations from the state as well
23	as any public health or other human services contracted to the district or authority
24	by the department.
