Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana. RACING/HORSE: Authorizes fixed odds wagering on horse races

| 12 | Be it enacted by the Legislature of Louisiana: |
| 13 | Section 1. R.S. 4:149(A) is hereby amended and reenacted and R.S. 4:200 is hereby |
| 14 | enacted to read as follows: |
| 15 | §149. Wagering; rules and regulations |
| 16 | A. The commission may prescribe rules and regulations under which shall |
| 17 | be conducted all horse races upon the results of which there is wagering. The |
| 18 | commission shall, as may be necessary, prescribe additional special rules and |
| 19 | regulations applicable separately to thoroughbreds and quarter horses. The |
| 20 | commission shall make rules governing, permitting, and regulating the wagering on |

| 1 | horse races under the form of mutuel wagering by patrons, known as pari-mutuel |

| 10 | A. There is hereby created in the state treasury a special fund to be known |
| 11 | as the Fixed Odds Horse Wagering Supplement Fund, hereafter referred to in this |

| 13 | B. Any appropriation by the legislature to the commission from the fund |
| 14 | shall be utilized to supplement breeder awards and purses for Louisiana bred |
| 15 | Thoroughbreds and Quarter Horses as provided in this Section. |

| 17 | manner as monies in the state general fund. Interest earned on the investments of |

Boyer

Abstract: Authorizes fixed odds wagering on horse races.

<u>Proposed law</u> defines "fixed odds wagering on horse races" as the acceptance of sports wagers on a sports event of a live or simulcast horse race with predetermined odds.

<u>Proposed law</u> defines a "fixed odds wager on horse races" as a sum of money or representation of value risked by a player on an occurrence associated with a sports event involving race horses for which the outcome is uncertain. The term includes single-race bets, teaser bets, moneyline bets, in-race wagering, proposition bets, straight bets, and parlays.

Proposed law authorizes the conducting of fixed odds wagering on horse races.

Proposed law creates the Fixed Odds Horse Wagering Purse Supplement Fund.

<u>Proposed law</u> provides that 55% of the monies in the fund goes to thoroughbred racing and 24% goes to quarter horse racing for purse supplements.

<u>Proposed law</u> provides that 14% of the monies in the fund goes to the Louisiana Thoroughbred Breeders Association and 7% to the Louisiana Quarter Horse Breeders Association for breeder awards.

<u>Proposed law</u> provides that these monies shall be issued to the Horsemen's Bookkeeper at the licensed racing association to be distributed in accordance with <u>proposed law</u>.

<u>Proposed law</u> provides that five percent of the net gaming proceeds from fixed odds wagering on horse races shall be credited to the Fixed Odds Horse Wagering Purse Supplement Fund.

Effective upon signature of governor or lapse of time for gubernatorial action.

- 3. Specify that licensees may accept fixed odds wagers with the approval of the host racetrack and the Horsemen's Benevolent and Protective Association.
