SENATE RESOLUTION NO. 105

BY SENATORS MYERS AND ALLAIN

SPECIAL DAY/WEEK/MONTH. Designates the month of May as ALS Awareness Month in Louisiana.

1	A RESOLUTION
2	To designate the month of May as ALS Awareness Month in Louisiana.
3	WHEREAS, Amyotrophic Lateral Sclerosis (ALS), known by many as Lou Gehrig's
4	disease, is a progressive fatal neurodegenerative disease in which a person's brain loses
5	connection with the muscles, slowly taking away the person's ability to walk, talk, eat, and
6	eventually breathe; and
7	WHEREAS, every ninety minutes someone is diagnosed with ALS and someone
8	passes away from ALS; and
9	WHEREAS, there is no known cure for ALS, and, on average, patients diagnosed
10	with ALS survive only two to five years from the time of diagnosis; and
11	WHEREAS, people who have served in the military are more likely to develop ALS
12	than those with no history of military service; and
13	WHEREAS, securing access to new therapies, durable medical equipment, and
14	communication technologies is of vital importance to people living with ALS; clinical trials
15	play a pivotal role in evaluating new treatments, enhancing quality of life, and fostering
16	assistive technologies for those living with ALS; and
17	WHEREAS, the ALS Association, as the largest philanthropic funder of ALS
18	research globally, has committed over \$154 million to support more than five hundred fifty

projects across the United States and eighteen other countries; and
