Organizes the state human services district under the secretary and surgeon general of the Louisiana Department of Health

Proposed law enacts R.S. 28:914(E) to require each human services district and authority board to submit an annual report summarizing its progress toward achieving statewide health goals as established by the Louisiana Department of Health (LDH). The report must include an overview of programs and initiatives, performance metrics relative to statewide goals, identified barriers to progress, and plans for improvement. Proposed law further requires LDH to develop and publish uniform reporting standards, metrics, and evaluation criteria, and to compile the district reports into a statewide summary to be submitted to the House and Senate committees on health and welfare by February 1 of each year.


