On page 9, line 10, after "**present**" insert "**, except under an extenuating circumstance that temporarily prevents compliance with this Paragraph**"

AMENDMENT NO. 4

On page 10, line 5, change "**child-to-staff**" to "**child to staff**"

AMENDMENT NO. 5

On page 10, line 13, after "**Section**" delete "**or**" and insert a "1"

AMENDMENT NO. 6

On page 10, line 14, after "**professionals**" insert "**, or when a child is in the custody of a parent or legal guardian**"

AMENDMENT NO. 7

On page 10, delete lines 19 through 23

AMENDMENT NO. 8

On page 10, line 24, change "**(14)**" to "**(12)**" and after "**permitted to**" change "**go to**" to "**use**"

AMENDMENT NO. 9

On page 10, line 27, after "**harm**" insert "**or to assist with an accident**"

AMENDMENT NO. 10

On page 10, after line 29, insert the following:

"(13) A child age five and older may be permitted to go to and return from the restroom without staff."

AMENDMENT NO. 11

On page 11, line 1, change "**(15)**" to "**(14)**"

AMENDMENT NO. 12

On page 11, line 2, after "**older**," insert "**staff shall ensure that the children enrolled in the prekindergarten program or early learning center are not unsupervised in the**"

1 restroom at the same time as any older children are using the restroom. For any facility
2 constructed after January 1, 2026,"

4 On page 11, delete lines 5 though 7 and insert the following:

5 "(15) Children shall be changed and cleaned immediately following a toileting
6 accident."

10 On page 15, between lines 17 and 18, insert the following:

11 "Section 4. R.S. 24:525(D) is hereby amended and reenacted to read as follows:

12 §525. State child ombudsman; duties

13 * * *

14 D.(1) Any state agency having responsibility for the custody or care of children shall
15 provide monthly notice to the state child ombudsman of the death of a child in its custody
16 or care.

17 (2) The Department of Children and Family Services shall notify the state child
18 ombudsman within seventy-two hours of receiving information on the death of any
19 child that had been reported to the department for alleged child abuse or neglect.
