**HOUSE RESOLUTION NO. 167** 

BY REPRESENTATIVE BAYHAM

HIGHER EDUCATION: Requests public postsecondary education institutions in Louisiana to adopt policies and procedures to combat antisemitism on campus

A RESOLUTION

2 To urge and request each public postsecondary education institution to adopt policies and 3 procedures to combat antisemitism on campuses and to report related data to the 4 Board of Regents. 5 WHEREAS, the state of Louisiana condemns all acts of hate and bias, including 6 antisemitism, and seeks to promote civil rights, safety, inclusion, and dignity for all 7 residents; and 8 WHEREAS, the state also affirms the right of all students, faculty, and staff at 9 postsecondary institutions to be free from discrimination and harassment on the basis of 10 religion, race, ethnicity, or national origin and recognizes that this is guaranteed under the 11 Fifth and Fourteenth Amendments to the Constitution of the United States of America and 12 Titles VI and VII of the Civil Rights Act of 1964; and 13 WHEREAS, Jewish students in Louisiana and across the country are targeted by acts 14 of hate, including threats, harassment, intimidation, and vandalism, on college campuses; 15 and 16 WHEREAS, according to the Anti-Defamation League's (ADL) annual audit of 17 antisemitic incidents, in 2024, there were 9,354 incidents of antisemitic assault, harassment, 18 and vandalism across the country, and this represents a 5% increase from 2023, a 19 344% increase over the past five years, and a 926% increase over the past ten years, reaching the highest level recorded by ADL; the audit also revealed that Louisiana has experienced 20 21 a nearly six-fold increase since 2020; and

1 WHEREAS, Jewish students are targeted for hate crimes at a higher per capita rate 2 than students belonging to any other group; and 3 WHEREAS, the International Holocaust Remembrance Alliance (IHRA) has 4 developed a working definition of antisemitism, and this definition is an appropriate guide 5 for policy and enforcement purposes. 6 THEREFORE, BE IT RESOLVED that the House of Representatives of the 7 Legislature of Louisiana does hereby urge and request each public postsecondary education 8 institution to adopt policies and procedures to combat antisemitism on campuses by 9 January 1, 2026, guided by the IHRA working definition and in compliance with Titles VI 10 and VII of the Civil Rights Act of 1964, the First Amendment to the Constitution of the 11 United States of America, and all applicable Louisiana laws. 12 BE IT FURTHER RESOLVED that such policies shall include, at a minimum, 13 provision for the following: 14 (1) At the start of each academic year, issuing a statement setting forth the 15 institution's commitment to fostering a campus environment that is free from discrimination 16 and harassment on the basis of religion, race, ethnicity, and national origin, including 17 antisemitism, and taking appropriate action to address and ameliorate such discrimination 18 and harassment when it occurs. 19 (2) At the start of each academic semester, notifying all students, staff, and faculty 20 of the institution's policies prohibiting discrimination and harassment on the basis of 21 religion, race, ethnicity, and national origin and retaliation for reporting discrimination and 22 harassment on those bases and the institution's policies and procedures for reporting 23 discrimination and harassment on the basis of religion, race, ethnicity, or national origin and 24 filing a complaint of discrimination, harassment, or retaliation. 25 (3) At the start of each academic semester, notifying all administrators, faculty, and 26 staff responsible for receiving reports and complaints of discrimination and harassment 27 based on religion, race, ethnicity, and national origin of their obligations under state and 28 federal civil rights laws when they receive such reports and complaints. 29 (4) Recognition, respect, and equal treatment for all student organizations, including 30 all Jewish and religious groups.

1 (5) The collection and annual reporting of data in accordance with state and federal 2 law including the number of antisemitism-related reports and complaints received by the 3 institution from students, faculty, staff, and community members; the number of 4 investigations of antisemitism conducted by or for the postsecondary institution by a third party, a description of the allegations investigated, the determinations made, and all 5 6 corrective actions taken; and the percentage of Title VI and Title VII complaints received 7 by the institution that involve antisemitism. 8 BE IT FURTHER RESOLVED that the institution shall report such data to the Board 9 of Regents not later than June thirtieth annually through June 30, 2028, and make the data 10 publicly available in accordance with state and federal law on the institution's website and 11 that the Board of Regents shall compile and submit a statewide summary to the House 12 Committee on Education not later than October thirty-first annually through October 31, 13 2028. 14 BE IT FURTHER RESOLVED that the collection, reporting, and disclosure of such 15 data shall be in accordance with state and federal law regarding the collection, maintenance, 16 use, and disclosure of personally identifiable information and that this Resolution shall not 17 be construed to restrict constitutionally protected speech, the freedom of association, or the 18 right to peacefully assemble. 19 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 20 commissioner of higher education, who shall disseminate it to the president of each public 21 postsecondary education system for dissemination to the system's institutions.
