HOUSE CONCURRENT RESOLUTION NO. 37

BY REPRESENTATIVES HUGHES, AMEDEE, BRASS, CARVER, EDMONSTON,
FREIBERG, AND TAYLOR AND SENATOR BOUDREAUX

HIGHER EDUCATION: Establishes the Hazing Prevention Task Force

1 A CONCURRENT RESOLUTION

2 To create the Hazing Prevention Task Force to evaluate the effectiveness of state anti-hazing
3 law and postsecondary education hazing prevention policies and practices.

4 WHEREAS, research shows that, at the postsecondary level, student engagement in
5 campus organizations can strengthen student outcomes, improve retention, and aid in
6 completion; and

7 WHEREAS, this benefit is only realized if student organizations' intake and
8 participation processes are safe and enriching for the students; and

9 WHEREAS, hazing of any kind is illegal and strictly prohibited, with laws in place
10 that provide penalties, which include jail time and fines for hazing deaths or serious bodily
11 injuries; and

12 WHEREAS, even with such strong laws, Louisiana continues to experience hazing
13 incidents that result in the death and serious bodily injury of students; and

14 WHEREAS, although illegal, hazing incidents can occur as part of the intake process
15 of various student organizations, including fraternities, sororities, bands, and athletic teams;
16 and

17 WHEREAS, the landmark 2008 National Study of Student Hazing revealed the
18 following alarming facts:

- 19 (1) Forty-seven percent of students come to college having experienced hazing;
20 (2) Fifty-five percent of college students involved in clubs, teams, and
21 organizations experience hazing;

1 (3) Seventy-four percent of students on a varsity athletic team and seventy-three
2 percent of social fraternity and sorority members reported experiencing
3 hazing; and

4 WHEREAS, Louisiana's public postsecondary education systems have self-reported
5 thirty-seven hazing incidents since the passage of the Max Gruver Act in 2018; and

6 WHEREAS, effective education and hazing prevention is of the utmost importance
7 in Louisiana; and

8 WHEREAS, identifying all challenges, appropriate solutions, and implementation
9 plans across institutions in the state will require significant engagement from institution and
10 system leaders and other stakeholders who are committed to improving campus safety.

11 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
12 create the Hazing Prevention Task Force to evaluate the effectiveness of state anti-hazing
13 law and postsecondary education hazing prevention policies and practices.

14 BE IT FURTHER RESOLVED that the task force shall be composed of the
15 following twenty-six members:

16 (1) One member appointed by the speaker of the House of Representatives who is
17 a member of the House of Representatives or a Louisiana resident, who shall serve as
18 chairman of the task force.

19 (2) Two members appointed by the speaker of the House of Representatives.

20 (3) The chairman of the House Committee on the Administration of Criminal Justice
21 or her designee.

22 (4) The chairman of the House Committee on Civil Law and Procedure or his
23 designee.

24 (5) The chairman of the House Committee on Education or her designee.

25 (6) The chairman of the House Committee on Health and Welfare or his designee.

26 (7) Four members of the Senate appointed by the president of the Senate, one of
27 whom shall serve as vice chairman of the task force, at the president's discretion.

28 (8) The attorney general or her designee.

29 (9) The superintendent of the Louisiana State Police or his designee.

30 (10) The commissioner of higher education or her designee.

1 (11) Four students, one enrolled at each public postsecondary education system in
2 Louisiana, nominated by each system president and appointed by the commissioner of higher
3 education.

4 (12) Four staff or faculty members, one employed at each public postsecondary
5 education system in Louisiana, who are engaged in student affairs, including overseeing
6 student code of conduct or student discipline, appointed by each system president.

7 (13) Four campus presidents or chancellors, or individuals who serve as system or
8 campus counsel, appointed by the president of each public postsecondary education system
9 in Louisiana.

10 BE IT FURTHER RESOLVED that the task force shall deliberate on all issues
11 relevant to the prevention of hazing at the postsecondary level, including but not limited to
12 the following:

13 (1) An evaluation of current state and federal laws, both criminal and civil, relative
14 to hazing at colleges and universities.

15 (2) An evaluation of current postsecondary education hazing prevention policies.

16 (3) An assessment of the adequacy of the criminal, civil, and academic consequences
17 for violating the laws and policies provided for in (1) and (2) above.

18 (4) A review of current best practices from across the country suitable for adoption
19 in Louisiana, such as the development of statewide hazing prevention training.

20 BE IT FURTHER RESOLVED that to inform the work of the task force, the task
21 force may engage with student focus groups to gather information and test the potential
22 impact of possible recommendations.

23 BE IT FURTHER RESOLVED that the Board of Regents shall provide staff support
24 to the task force, to be provided from existing personnel.

25 BE IT FURTHER RESOLVED that non-legislative members of the task force shall
26 receive no compensation for their services and shall serve at no expense to the state.

27 BE IT FURTHER RESOLVED that student members of the task force may receive
28 reimbursement for travel as authorized and paid for by their respective institution's president
29 or chancellor.

1 BE IT FURTHER RESOLVED that all non-legislative and non-student members
2 may seek reimbursement for travel, contingent upon authorization by the head of their
3 respective employer.

4 BE IT FURTHER RESOLVED that the task force shall submit a written report of
5 findings and recommendations to the House and Senate committees on education, the House
6 Committee on the Administration of Criminal Justice, and the House Committee on Civil
7 Law and Procedure not later than January 31, 2026.

8 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
9 commissioner of higher education.
