5	Representatives of the Legislature of Louisiana has learned of the untimely passing, on
6	January 3, 2025, of Garrett Logan Maxwell; and
7	WHEREAS, Garrett was born on November 29, 2001, in Plant City, Florida, to Brian
8	Maxwell and Melanie Griffin Maxwell; he attended elementary and middle school in Plant
9	City, instantly making friends and excelling as a student and athlete; and
10	WHEREAS, after his family moved to Mississippi, Garrett continued his athletic
11	pursuits by playing baseball in local leagues and football at West Lincoln School; when his
12	family moved to Franklinton, Louisiana, Garrett enrolled in junior high school and became
13	a three-year varsity starter in baseball; he was the 2018 and 2019 James Ard Award winner
14	as selected by his peers for being the hardest working player on the Franklinton High School
15	baseball team; Garrett graduated at the top of his class; and
16	WHEREAS, Garrett attended Louisiana State University and was preparing to
17	graduate in December 2025 with a degree in finance and a degree in information systems
18	and analytics; he was a member of Pi Kappa Alpha Fraternity and a former member of LSU
19	Student Government and the Association of Information Technology Professionals; and

1 WHEREAS, Garrett was an avid golfer who spent most of his free time on the golf 2 course or honing his skills at Topgolf; he had an affable nature that made him easy to love, 3 and he treated everyone he met with the care and attention expected from a lifelong friend; 4 and

5 WHEREAS, Garrett was devoted to his beloved girlfriend, Taylor Mayer, and both 6 she and her family were very important to him; the Mayer family's devotion to him during 7 his most challenging days brought him comfort and happiness despite his physical suffering; 8 and

9 WHEREAS, Garrett passed away at Baylor St. Luke's Medical Center in Houston, 10 Texas, after a five-and-a-half month battle with myocarditis; he is survived by his mother, 11 Melanie Griffin (Adam Waldon); father, Brian Maxwell (Kristina); grandmothers, Wanda 12 Laird Griffin and Linda Maxwell Welch; brother, Hunter Maxwell; sisters, Courtney 13 Maxwell Temple (Ryan) and Cadie Maxwell Cole (Chris); nieces, Charleigh Temple and 14 Alyvia Bacot; nephew, Eli Cole; aunts and uncles, Tré and Amy Griffin, Jeff and Kaci 15 Griffin, Kevin and Robin Laird, and Scott and Wendy Maxwell; girlfriend, Taylor Mayor, 16 and her parents, Eddie and Shelley; and a host of extended relatives and close friends; he 17 will be deeply missed, but the legacy of his love shall live on in perpetuity in the hearts and 18 minds of those who were privileged to have known him.
