2	To designate Monday, June 30, 2025, as Arthrogryposis Multiplex Congenita (AMC)		
3	Awareness Day at the state capitol and to commend Paisley Grace Langton and		
4	others who face AMC.		
5	WHEREAS, Arthrogryposis multiplex congenita is a condition that causes joints to		
6	be stiff and crooked at birth; a newborn with arthrogryposis lacks the normal range of		
7	motion in one or more joints; the condition develops prenatally and can be caused by an		
8	underlying condition or syndrome; and		
9	WHEREAS, AMC is an umbrella diagnosis, meaning it is a part of many other		
10	conditions and syndromes, and there are more than four hundred variations of the disease;		
11	the most common form of AMC is amyoplasia; and		
12	WHEREAS, a newborn must have at least three contracted joints in two separate		
13	body areas to be diagnosed with AMC, and the condition occurs in one out of every three		
14	thousand births; and		
15	WHEREAS, AMC can affect the joints of the hands, feet, hips, knees, elbows,		
16	shoulders, wrists, fingers, toes, jaw, and spine, and the symptoms of the disease vary from		
17	person to person; and		
18	WHEREAS, Paisley Langton is a resident of Sabine Parish who is battling AMC like		
19	many other children across the world; though the condition is not curable, patients receive		
20	treatment that allows them to live with as much independence in their daily lives as possible.
