| 9 | WHEREAS, the Distinguished Service Award is the most prestigious honor offered |
| 10 | to sports media in the state and recipients are carefully chosen after an extensive deliberation |
| 11 | by a forty-member expert panel based on their professional accomplishments in local, state, |
| 12 | regional, and national arenas; and |
| 13 | WHEREAS, Glenn Guilbeau is the recipient of the 2025 Distinguished Service |
| 14 | Award in Sports Journalism and a member of the 2025 Louisiana Sports Hall of Fame |
| 15 | Induction Class; and |
| 16 | WHEREAS, a native of metropolitan New Orleans and longtime resident of Baton |
| 17 | Rouge, Glenn Guilbeau has dedicated his professional life to chronicling and elevating the |
| 18 | stories of athletics throughout the southeastern United States, particularly in the Southeastern |

| 2 | WHEREAS, a graduate of the University of Missouri's prestigious School of |
| 3 | Journalism, Guilbeau is widely regarded as one of the most respected and recognizable |
| 4 | sportswriters in the South; and |
| 5 | WHEREAS, Guilbeau has earned numerous national and state level accolades |
| 6 | throughout his career, including honors from the Football Writers Association of America |
| 7 | (FWAA), the Associated Press Sports Editors (APSE), and the National Sports Media |
| 8 | Association (NSMA), along with multiple awards from the Louisiana Sports Writers |
| 9 | Association (LSWA); and |
| 10 | WHEREAS, in the 2020-2021 season alone, Guilbeau won first place from the |
| 11 | FWAA for his game story on LSU's upset win over Florida, he was named Beat Writer of |
| 12 | the Year by the LSWA, and he placed in three separate APSE categories: Beat Writing, |
| 13 | Explanatory Writing, and Game Coverage; and |
| 14 | WHEREAS, Guilbeau was previously named the FWAA's first-place columnist in |
| 15 | 2017, and the top overall national winner in 2016, placing first in game stories, second in |
| 16 | columns, and receiving honorable mention for features; and |
| 17 | WHEREAS, he was named Louisiana's Sportswriter of the Year by the NSMA in |
| 18 | both 2007 and 2014 and he continues to receive recognition for his insightful reporting and |
| 19 | exceptional storytelling; and |
| 20 | WHEREAS, Guilbeau began his Louisiana journalism career at The Town Talk in |
| 21 | Alexandria in the late 1980s and he swiftly emerged as one of the top beat writers in the |
| 22 | SEC; and |
| 23 | WHEREAS, over the course of his career, Guilbeau has covered major SEC |
| 24 | programs including Alabama and Auburn, and he was a leading voice on the LSU beat from |
| 25 | 1998 through 2021 while writing for The Advocate and many other publications in |
| 26 | Louisiana; and |
| 27 | WHEREAS, in 2021, he became a feature writer and reporter for Outkick.com, |
| 28 | continuing to inform and engage sports fans while maintaining his Louisiana roots; and |
| 29 | WHEREAS, he now serves as editor of <i>Tiger Rag</i> , continuing his commitment to |

covering LSU athletics with the same excellence, integrity, and insight that have defined his
