3	Louisiana and to offer congratulations and best wishes upon the occasion of her
4	retirement following twenty-two years of dedicated public service.
5	WHEREAS, Amanda Ames has announced her retirement following a distinguished
6	twenty-two-year career devoted to the public health and welfare of Louisiana's citizens
7	through her exemplary service in the water industry; and
8	WHEREAS, Amanda began her tenure with the Safe Drinking Water Program in
9	2002 as an engineer intern and steadily advanced through a variety of increasingly
10	responsible roles, including District Engineer in her hometown of Lafayette, and later
11	managing grants, contracts, and compliance with state and federal rules; and
12	WHEREAS, Amanda's broad experience and deep knowledge uniquely qualified her
13	to assume the role of Chief Engineer of the Bureau of Engineering Services in 2015, a
14	position in which she has overseen the regulation and infrastructure of over 1,240 water
15	systems across the state; and
16	WHEREAS, in this critical leadership position, Amanda has directed key programs
17	such as the Operator Certification Program, the Drinking Water Revolving Loan Fund
18	Program, and the Community Sewerage Program; and

1	WHEREAS, Amanda has been a steadfast leader during some of the state's most
2	challenging times, including public health crises and devastating natural disasters such as
3	hurricanes Laura, Delta, and Ida, ensuring essential water system operations were maintained
4	and reported for the benefit of the public and critical institutions such as hospitals, schools,
5	dialysis centers, and nursing homes; and
6	WHEREAS, Amanda has actively contributed to state and national water policy
7	through her service on numerous important committees and boards, including the Governor's
8	Louisiana Rural Water Infrastructure Committee, the Louisiana Operator Certification
9	Committee, the Sewage Overflow Commission, the LSU Biological Engineering Advisory
10	Council, and as a board member of the Association of State Drinking Water Administrators
11	(ASDWA); and
12	WHEREAS, Amanda's outstanding service and impact have been formally
13	recognized through awards such as the NextGen Courageous Champion Public Service
14	Award in 2020 and the 2022 Distinguished Alumni Award from the LSU Biological
15	Engineering Department; and
16	WHEREAS, under Amanda's guidance and leadership, Louisiana achieved numerous
17	critical program milestones, including:
18	• Response to the Town of St. Joseph Lead Public Health Emergency;
19	• Establishment of state bacteriological and disinfection by-product sample
20	collection;
21	Adoption of Louisiana Public Water System Design Standards and
22	Significant Deficiencies regulations;
23	• Launch of the Public Health Water Infrastructure Consolidation Initiative;
24	• Formation of the Rural Water Infrastructure Commission (RWIC);
25	• Implementation of the Lead Testing Program for Childcare and Schools
26	Drinking Water;
27	Creation of the Community Water System Accountability Rule;
28	Development and management of the Louisiana Water Sector Program
29	(WSP);
30	• Coordination of funding through the Bipartisan Infrastructure Law (BIL);
