- Formation of the Rural Water Infrastructure Commission (RWIC);
- Implementation of the Lead Testing Program for Childcare and Schools

- Creation of the Community Water System Accountability Rule;
- Development and management of the Louisiana Water Sector Program (WSP);
- Coordination of funding through the Bipartisan Infrastructure Law (BIL);
- Introduction of Water System Grades; and
- Advancement of the Lead and Copper Rule Revisions and Lead Service Line
   Inventories; and

WHEREAS, Amanda Ames' career is a testament to her unwavering commitment, visionary leadership, technical expertise, and genuine care for the health and well-being of the people of Louisiana.
