LAW ENFORCE/CRIM JUS COM: Requests the La. Commission on Law Enforcement and Administration of Criminal Justice and all La. state and local law enforcement agencies to improve crime data reporting

1	A CONCURRENT RESOLUTION
2	To urge and request the Louisiana Commission on Law Enforcement and Administration of
3	Criminal Justice and all Louisiana state and local law enforcement agencies, jointly,
4	to improve crime data reporting in order to be in full compliance with the National
5	Incident Based Reporting System, hereinafter referred to as "NIBRS", provided by
6	the Federal Bureau of Investigation, hereinafter referred to as "FBI", by analyzing
7	progress towards, obstacles to, and recommendations for full NIBRS compliance in
8	an annually published, publicly available, report.
9	WHEREAS, rigorous empirical study of the social, economic, demographic,
10	geographic, and environmental factors that drive different types of criminal behavior is
11	necessary to support scientific, evidence-based policing; and
12	WHEREAS, rigorous empirical study is needed to determine whether and which
13	federal, state, and local programs impact criminal behavior is necessary to support scientific,
14	evidence-based policies; and
15	WHEREAS, data is needed for a rigorous empirical study; and
16	WHEREAS, the relational database structure of NIBRS better captures the
17	complexity and diversity of incidents compared to its predecessor, the Summary Reporting
18	System; and
19	WHEREAS, the FBI reported in 2023 that forty-eight percent, or one hundred fifty-
20	two agencies submitted NIBRS data, which is low for the three hundred fifteen agencies

- 1 reported as NIBRS certified by the Louisiana Commission on Law Enforcement and
- 2 Administration of Criminal Justice; and
- 3 WHEREAS, the reporting status of individual agencies is then inconsistent and not

4 continuous over the past years.

- 5 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
- 6 urge and request state and local law enforcement agencies to become NIBRS compliant as
- 7 soon as possible.
- 8 BE IT FURTHER RESOLVED that the Louisiana Commission on Law Enforcement
- 9 and Administration of Criminal Justice publish a publicly available annual report detailing
- 10 the progress towards complete compliance with the NIBRS provided by the FBI.
