It 15 shall also administer the food stamp program or its successor, child support programs, establishment of paternity programs, disaster relief grant programs for individuals and 16 17 families, and such other programs as assigned by the secretary. It shall also conduct 18 disability and other client eligibility determinations, and may conduct medical assistance elient eligibility determinations. The office is authorized to enter into interagency 19 20 agreements with other state agencies to conduct eligibility determinations. The office shall 21 provide for the public child welfare functions of the state including but not limited to 22 prevention services that promote, facilitate, and support activities to prevent child abuse and 23 neglect; child protective services; voluntary family strengthening and support services; 24 making permanent plans for foster children and meeting their daily maintenance needs of 25 food, shelter, clothing, necessary physical medical services, school supplies, and incidental 26 personal needs; and adoption placement services for foster children freed for adoption. It 27 shall also perform the functions of the state relating to the licensing of facilities regulated 28 under Chapter 14 of Title 46 of the Louisiana Revised Statutes of 1950. The office shall 29 issue and monitor domestic violence services contracts.
