INSURANCE DEPARTMENT: Requests the Department of Insurance to annually submit comprehensive reports of received complaints relative to property and casualty insurance companies

A RESOLUTION

2 To urge and request the Department of Insurance to annually provide a comprehensive 3 report detailing the number of complaints received against property and casualty 4 insurance companies and the department's response to such complaints. 5 WHEREAS, the Department of Insurance plays a crucial role in regulating the 6 insurance industry and protecting consumers; and 7 WHEREAS, transparency regarding complaints against property and casualty 8 insurance companies, especially concerning unpaid or denied claims, is essential for 9 legislative oversight and ensuring consumer protection; and 10 WHEREAS, currently, there is no statutory requirement for the Department of 11 Insurance to annually report to the legislative insurance committees on the volume and 12 disposition of such complaints. 13 THEREFORE, BE IT RESOLVED that the House of Representatives of the 14 Legislature of Louisiana does hereby urge and request the Department of Insurance to 15 annually provide a comprehensive report detailing the number of complaints received 16 against property and casualty insurance companies and the department's response to such 17 complaints. 18 BE IT FURTHER RESOLVED that the Department of Insurance shall annually 19 submit the report to the House and Senate committees on insurance detailing all of the 20 following:

The total number of complaints received against property and casualty insurance
 companies during the preceding calendar year.

- 2. Details of the complaints, including the type of complaint with specific emphasis
 on whether the complaint pertains to unpaid or denied claims.
- 3. The number of complaints that resulted in regulatory or enforcement actions
 against the property and casualty insurance companies.
- 4. Any trends or patterns observed in the nature of complaints and the actions taken
 by the commissioner of insurance.
- 9 BE IT FURTHER RESOLVED that the Department of Insurance shall submit the 10 report to the House and Senate committees on insurance by March first of each year.
- BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the commissioner of insurance.
