A STUDY REQUEST

2	To the House Committee on Ways and Means and the House Committee on Insurance to
3	meet and to function as a joint committee to study the feasibility of establishing a
4	Catastrophe Reinsurance Program which includes the issuance of catastrophe bonds
5	to provide an alternative method for insurance companies to secure reinsurance to
6	cover property damage and casualty losses associated with hurricanes and other
7	natural catastrophe losses in Louisiana, and to report the findings of the joint
8	committee to the legislature prior to January 31, 2026.
9	WHEREAS, the House Ways and Means Committee, in hearings during the 2025
10	Regular Session concerning the issuance of catastrophe bonds for the Catastrophe
11	Reinsurance Program, particularly House Bill No. 672 by Representative Jordan, discussed
12	and determined that it was appropriate and necessary for the committee to conduct interim
13	hearings to study the feasibility of establishing a Catastrophe Reinsurance Program which
14	includes the issuance of catastrophe bonds to provide an alternative method for insurance
15	companies to secure reinsurance to cover property damage and casualty losses associated
16	with hurricanes and other natural catastrophe losses in Louisiana; and
17	WHEREAS, Louisiana homeowners are experiencing an insurance crisis as a result
18	of hurricanes and other catastrophic flooding and weather-related events that have recently
19	occurred in this state; and

1 WHEREAS, property insurance rates and premiums have increased for many 2 residents of this state and are becoming unaffordable; and 3 WHEREAS, establishment of a Catastrophe Reinsurance Program could offer an 4 alternative method for insurance companies to secure reinsurance in an effort to bring 5 stability and affordability back to this state's citizens in securing homeowner's insurance by 6 transferring the risk of casualty losses to a wider set of investors and helping insurance 7 companies manage natural catastrophe losses. 8 THEREFORE, the Legislature of Louisiana requests the House Committee on Ways 9 and Means and the House Committee on Insurance to meet and to function as a joint 10 committee to study the feasibility of establishing a Catastrophe Reinsurance Program which 11 includes the issuance of catastrophe bonds to provide an alternative method for insurance 12 companies to secure reinsurance to cover property damage and casualty losses associated 13 with hurricanes and other natural catastrophe losses in Louisiana, and to report the findings 14 of the joint committee to the legislature prior to January 31, 2026. 15 THEREFORE, the Legislature of Louisiana requests the joint committee to consider 16 input from interested parties, including insurance companies, and to review programs that 17 have been adopted in states that have suffered similar property and casualty losses from 18 hurricanes, catastrophic flooding, wildfires, and other weather-related events to address the 19 insurance needs of its citizens.
