22 regarding delays caused solely by the unjustifiable delinquency of a utility in the
23 completion of relocation work. The chief engineer, or his duly authorized
24 representative, may decline the issuance of a permit to any utility company that is
25 unjustifiably delinquent in completing a relocation project and shall continue to so
26 decline until such a project is completed."
