HOUSE RESOLUTION NO. 311

BY REPRESENTATIVE AMEDEE

HEALTH: Requests the Louisiana Department of Health to assess information regarding restorative reproductive health practices

1 A RESOLUTION

2 To urge and request the Louisiana State Board of Medical Examiners and Louisiana
3 Department of Health to conduct an assessment of reproductive health practices and
4 submit a report of their findings no later than June 30, 2026.

5 WHEREAS, reproductive health conditions are the leading causes of infertility,
6 which affects fifteen to sixteen percent of couples in the United States. Such conditions
7 include endometriosis, adenomyosis, polycystic ovary syndrome, uterine fibroids, blocked
8 fallopian tubes, hormone imbalances, hyperprolactinemia, thyroid conditions, ovulation
9 dysfunctions, and other health conditions; and

10 WHEREAS, there is a growing interest among women to proactively assess their
11 overall health and understand how factors such as age and medical history contribute to
12 reproductive health and fertility; and

13 WHEREAS, restorative reproductive medicine (RRM) is a holistic approach to
14 reproductive health that focuses on identifying and treating the underlying causes of
15 reproductive dysfunction, rather than merely addressing symptoms; and

16 WHEREAS, RRM incorporates various methods, including fertility awareness
17 methods (FAMs), lifestyle adjustments, and medical treatments, to support natural
18 conception and healthy pregnancies; and

19 WHEREAS, women are worthy of the highest standard of medical care, including
20 the opportunity to assess, understand, and improve their reproductive health. Unfortunately,

1 many women do not receive adequate information about their reproductive health and do not
2 have access to restorative reproductive approaches; and

3 WHEREAS, it would be helpful to expand and promote data collection on
4 reproductive health conditions; and

5 WHEREAS, it would be helpful to identify the availability and utilization of
6 restorative reproductive treatments.

7 THEREFORE, BE IT RESOLVED that the House of Representatives of the
8 Legislature of Louisiana does hereby urge and request the Louisiana State Board of Medical
9 Examiners and the Louisiana Department of Health to assess the resources available for
10 women to be aware and access restorative reproductive practices and provide a report by
11 June 30, 2026, to the House and Senate Health and Welfare committees.

12 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
13 secretary of the Louisiana Department of Health and the executive director of the Louisiana
14 State Board of Medical Examiners.
