6	of Sidney H. Cates, III; and
7	WHEREAS, born on March 10, 1931, in New Orleans, Louisiana, Sidney H. Cates,
8	III, dedicated his life to the service of his country and community; he was a proud United
9	States Army veteran who served during the Korean War, and he carried the core values of
10	discipline, duty, integrity, and honor throughout his life; and
11	WHEREAS, following his military service, Mr. Cates embarked on a distinguished
12	career in law enforcement, joining the New Orleans Police Department in 1955; he
13	possessed an unwavering commitment to justice and earned a series of monumental
14	promotions over the course of his career, becoming the department's first African-American
15	sergeant, lieutenant, captain, and deputy chief of police; and
16	WHEREAS, Mr. Cates served during a challenging era of segregation and civil
17	rights, earning the sincere respect of his colleagues and the community he faithfully served;
18	he forged a legacy within the department and the city of New Orleans that endures as a
19	symbol of progress, perseverance, and public service; and
20	WHEREAS, outside of his professional life, Mr. Cates was a devoted husband to his
21	beloved wife of sixty-eight years, the late Betty Foster Cates, and a loving father,

1 grandfather, and great-grandfather; he was actively involved in civic and community affairs, 2 and his affiliations included the New Orleans Housing Authority, Hibernia Bank, Harrah's 3 Casino-New Orleans, the Office of Attorney General William "Billy" Guste, Giarrusso 4 Security Company, Townsmen Social & Pleasure Club, Original Illinois Social & Pleasure 5 Club, Stud's Club Social and Pleasure, Fraternal Order of Police, and the Sugar Bowl 6 Committee; and 7 WHEREAS, Sidney H. Cates, III, is survived by his children, Sidney Cates, IV 8 (Ava), and Kim Cates Parker (Lionel); grandchildren, Sidney H. Cates, V (Catherine),

Lauren Ann Warner (Rodney), Rebecca Parker, and Abigail Parker Lincoln (Jordan); and six great-grandchildren; he will be deeply missed, but the legacy of his service to the city of New Orleans shall live on in perpetuity in the hearts and minds of those who were privileged
