1	A RESOLUTION
2	To commend Devarjaye "DJ" Daniel for his strength, resilience, and lifelong dream of
3	becoming a police officer and to recognize his family for their unwavering support
4	and dedication.
5	WHEREAS, in 2018, at the young age of six years old, DJ Daniel was diagnosed
6	with brain and spinal cancer and given five months to live; and
7	WHEREAS, despite overwhelming odds, seven years and more than thirteen brain
8	surgeries later, DJ continues to fight cancer courageously, embodying the spirit of childhood
9	resilience and living life to the fullest; and
10	WHEREAS, after witnessing law enforcement officers spring into action following
11	the devastating aftermath of Hurricane Harvey, DJ decided that he wanted to be a police
12	officer; and
13	WHEREAS, DJ has been sworn in as an honorary police officer by more than one
14	thousand three hundred law enforcement agencies across the country, each time bringing
15	awareness to the complexities of childhood cancer; and
16	WHEREAS, DJ's greatest law enforcement honor came during a March 2025 joint
17	address to Congress, when President Donald J. Trump swore him in as an honorary U.S.
18	Secret Service agent; and

1	WHEREAS, DJ, his father, Theodis Daniel, and his extended family have inspired
2	countless people with their strength, hope, and bond, representing the very best qualities
3	found in those who serve each other with kindness and protect our communities; and
4	WHEREAS, DJ is a remarkable young man and role model to all who hear his story;

6	WHEREAS, his father has worked tirelessly to help make DJ's dream of becoming
7	a police officer a reality, setting a powerful example of dedication, advocacy, and parental
8	love.
9	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
10	does hereby commend Devarjaye "DJ" Daniel for his brave fight and hereby honors DJ and
11	his family for their strength, perseverance, and the inspiration they continue to provide
12	across our state and this great nation.
