Proposed law requires any municipality or parish, which issues a permit for construction, to permit and inspect all buildings for roof construction and reroofing in compliance with the International Building Code Chapter 15 requirements and rules promulgated by the Louisiana State Uniform Construction Code.

Proposed law requires any municipality or parish, which issues a permit for construction, to permit and inspect all dwellings for roof construction and reroofing in compliance with the International Residential Building Code Chapters 8 and 9 requirements and rules promulgated by the Louisiana State Uniform Construction Code.

EXPENDITURE EXPLANATION

Proposed law may result in an increase in Local Fund expenditures to the extent municipalities or parishes are not currently requiring permits and inspections for roof construction and reroofing based on the rules promulgated by the Louisiana State Uniform Construction Code. The LFO anticipates that any increase in expenditure related to these permits will be offset by the fee charged for the permit and inspection.

REVENUE EXPLANATION

Proposed law may result in an increase in Local Fund revenues if municipalities or parishes collect fees for permits and inspections for roof construction and reroofing. The LFO anticipates that any increase in revenue will be used to offset the cost of permitting and inspecting.
