2 To commend the Louisiana Association of Business and Industry on the occasion of its 3 fiftieth anniversary. 4 WHEREAS, the Louisiana Association of Business and Industry (LABI) is driven 5 by its mission to champion a vibrant and sustainable business climate in Louisiana by 6 promoting free enterprise to drive economic opportunities, improving the lives of everyday 7 citizens; and 8 WHEREAS, LABI was established on September 4, 1975, by consolidating the 9 Louisiana State Chamber of Commerce, the Louisiana Manufacturers Association, and the 10 Louisiana Political Council; the board of directors selected Ed Steimel to lead the 11 organization as its first president; and 12 WHEREAS, the core values of LABI are as follows: to act with honesty and uphold 13 the highest moral and ethical principles; to promote teamwork, open communication, and 14 collective problem solving on any endeavor; to exhibit determination, passion, agility, and 15 persistence to reach a goal; to strive for the highest professional quality in all initiatives, 16 programs, and interactions; and to treat all individuals with dignity while being considerate 17 of their time and commitments; and 18 WHEREAS, LABI represents more than two thousand Louisiana employers, and it 19 is the only association that represents businesses of all sizes from a statewide multi-industry 20 perspective; the organization serves its broad membership by working towards the singular 1
