TRANSPORTATION: Urges and requests the Department of Transportation and Development to study the feasibility of installing more safety measures and implementing new infrastructure on certain portions of Louisiana Highway 182

| 3 | feasibility of installing road safety measures and constructing new infrastructure, |
| 4 | including pedestrian crosswalks, an overpass, flashing warning signals, and more |
| 5 | visible road surface markings from Interstate 10 (I-10) and Interstate 49 (I-49) on |
| 6 | Louisiana Highway 182 (LA-182) to the intersection of East Pinhook Road. |
| 7 | WHEREAS, street improvements are necessary not only for motorists but also for |
| 8 | pedestrians who frequently travel along LA-182 and the East Pinhook Road intersection; and |
| 9 | WHEREAS, the National Association of City Transportation Officials recommends |
| 10 | the use of crosswalks on streets with higher volumes, higher speeds, or more lanes; and |
| 11 | WHEREAS, marked crosswalks and pedestrian warning signs can improve safety |
| 12 | for pedestrians crossing the road, but alone may not be sufficient for drivers to visibly locate |
| 13 | crossing locations to yield to pedestrians; and |
| 14 | WHEREAS, to improve the safety of crosswalks, the Federal Highway |
| 15 | Administration (FHWA) suggests enhancing visibility of the crosswalks, installation of |
| 16 | lighting, and sign and pavement markings; and |
| 17 | WHEREAS, according to the FHWA, the installation of rectangular rapid flashing |
| 18 | beacons enhance pedestrian conspicuity and increase driver awareness at crosswalks; and |
| 19 | WHEREAS, the FHWA reports that approximately a quarter of traffic fatalities and |
| 20 | a half of all traffic injuries in the United States occur at intersections; and |

| 1 | WHEREAS, according to the Texas A&M Transportation Institute, grade separation |

| 2 | through the use of overpasses on areas with high volume traffic relieves congestion and |
| 3 | improves safety for pedestrians and drivers; and |
| 4 | WHEREAS, LA-182 is a major corridor in Lafayette Parish, with approximately |
| 5 | seventy thousand drivers on the highway per day; and |
| 6 | WHEREAS, located along LA-182 are hotels, businesses, restaurants, churches, and |
| 7 | shopping centers, creating significant pedestrian traffic; and |
| 8 | WHEREAS, there are currently no crosswalks, flashing warning signals, or visible |
| 9 | road surface markings along LA-182 near I-49 and I-10; and |
| 10 | WHEREAS, according to The Current, a non-profit news organization serving |
| 11 | Lafayette, the list of pedestrian and bike-rider deaths is substantial on LA-182; and |
| 12 | WHEREAS, the Center for Analytics and Research in Transportation Safety's data |
| 13 | on Lafayette reports that there was a one hundred sixty-eight percent increase in fatal or |
| 14 | serious injury accidents from 2019 to 2023; and |
| 15 | WHEREAS, beginning in January 2025, the Department of Transportation and |
| 16 | Development began a rehabilitation project on the section of LA-182 from the railroad |
| 17 | junction to the I-10 and I-49 Interchange; and |
| 18 | WHEREAS, this project does not include improvements related to pedestrian safety; |
| 19 | and |
| 20 | WHEREAS, according to The Daily Advertiser, a newspaper in Lafayette, fifty-four |
| 21 | car accidents occurred on West Pinhook Road over the course of eighteen months; and |
| 22 | WHEREAS, the current road surface markings at the intersection of LA-182 and East |
| 23 | Pinhook Road are faded and barely visible; and |
| 24 | WHEREAS, there are no flashing warning signals or other signage at the intersection |
| 25 | of LA-182; and |
| 26 | WHEREAS, the installation of well-designed pedestrian crosswalks with appropriate |
| 27 | signage and signal timing will improve safety and mobility for pedestrians along LA-182 |
| 28 | near I-49 and I-10; and |
| 29 | THEREFORE, BE IT RESOLVED that the House of Representatives of the |
| 30 | Legislature of Louisiana does hereby urge and request the Department of Transportation and |

- 1 Development to study the feasibility of installing road safety measures and constructing new
- 2 infrastructure, including pedestrian crosswalks, an overpass, flashing warning signals, and
- 3 more visible road surface markings from I-10 and I-49 on LA-182 to the intersection of East

- 5 BE IT FURTHER RESOLVED that the Department of Transportation and
- 6 Development shall submit a written report detailing its findings to the House Committee on
- 7 Transportation, Highways and Public Works by August 1, 2026.
- 8 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 9 secretary of the Department of Transportation and Development.
