HOUSE CONCURRENT RESOLUTION NO. 68

## A CONCURRENT RESOLUTION

To urge and request the Department of Transportation and Development to study the feasibility and take appropriate steps to add a third lane to the Interstate 10 (I-10)

East off-ramp on Siegen Lane in Baton Rouge, Louisiana, to improve traffic flow and enhance public safety.

WHEREAS, the Siegen Lane interchange in East Baton Rouge Parish is one of the most heavily traveled access points along I-10, regularly experiencing traffic backups, especially during morning and evening peak hours; and

WHEREAS, the I-10 East off-ramp on Siegen Lane currently consists of one lane that opens into two lanes as it joins the access road coming from the Mall of Louisiana, and then expands to five lanes at the signal-two turning northbound onto Siegen Lane, one continuing straight to the I-10 East on-ramp, and two turning southbound onto Siegen Lane; and

WHEREAS, despite the lane expansions near the signal, the limited capacity of the ramp's initial segment contributes to significant congestion, particularly at the point of transition from the interstate to the access roads; and

WHEREAS, the persistent congestion at this location not only delays commuters and commercial vehicles but also increases the likelihood of traffic incidents and hinders emergency response times; and

WHEREAS, the current two-lane ramp can no longer accommodate the high traffic demand, contributing to inefficient flow and creating ongoing safety hazards for drivers; and

WHEREAS, the addition of a third lane at this interchange could significantly ease traffic congestion, allow for safer lane transitions, and improve overall driving conditions for the thousands of motorists who rely on this corridor daily; and

HCR NO. 68 ENROLLED

WHEREAS, strategic investment in critical transportation infrastructure such as the

I-10 East off-ramp at the Siegen Lane interchange is consistent with the Department of

Transportation and Development's mission to enhance the safety, reliability, and efficiency

of Louisiana's roadway network for all users; and

WHEREAS, the timely improvement of traffic conditions and safety measures at the

I-10 East off-ramp on Siegen Lane is essential to promoting economic vitality, protecting

the health and safety of the public, and maintaining a transportation infrastructure capable

of accommodating the current and future needs of the state of Louisiana.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby

urge and request the Department of Transportation and Development to study the potential

of expanding the I-10 East off-ramp on Siegen Lane by adding a third lane to improve traffic

flow and enhance public safety.

BE IT FURTHER RESOLVED that the Department of Transportation and

Development shall submit a report summarizing its findings on the benefits of expanding the

I-10 East off-ramp on Siegen Lane by adding a third lane to improve traffic flow and

enhance public safety to the House and Senate Committees on Transportation, Highways and

Public Works by August 1, 2026.
