A RESOLUTION

2	To urge and request the Louisiana Housing Corporation to monitor changes to terms and
3	conditions of equity commitments made by investors to development projects in the
4	state.
5	WHEREAS, affordable housing development in Louisiana relies heavily on equity
6	investments secured through tax credit partnerships, and the Louisiana Housing Corporation
7	(LHC) is the designated "housing finance agency" to allocate and administer tax credits for
8	the entire state; and
9	WHEREAS, developers and housing projects depend on the stability and reliability
10	of the equity commitments made by tax credit partners to ensure successful project
11	completion and long-term affordability; and
12	WHEREAS, the Low-Income Housing Tax Credit Program serves to finance
13	construction and rehabilitation of rental housing for low-income individuals and incentivize
14	private developers and investors to provide more low-income housing; and
15	WHEREAS, unforseen changes to the terms and conditions of equity commitments
16	made by investors can jeopardize the viability of a project, place financial burdens on
17	developers, and threaten the availability of affordable housing; and
18	WHEREAS, proactive monitoring of such changes by the LHC is essential to
19	safeguard developers, housing projects, and the state's affordable housing objectives.
