8	§136. Purpose
9	In an effort to control the rising number of abandoned or blighted properties
10	throughout the state and to slow urban blight, the legislature finds it necessary to
11	implement a mechanism by which the city of New Orleans, and the city of
12	Grambling, and the parish of East Baton Rouge and its municipalities are
13	empowered to more readily obtain abandoned or blighted properties. The provisions
14	of this Part are intended to provide a means by which governing authorities may
15	revitalize economically depressed areas by placing abandoned or blighted properties
16	back into the economic stream of commerce through the rehabilitation of the
17	abandoned or blighted property. The procedure created by this Part shall be in
18	addition to any other procedure authorized by law.
19	§136.1. Definitions
20	For the purposes of this Part, unless the context clearly otherwise requires or
21	unless otherwise defined in specific portions of this Part, the following words or
22	phrases shall have the respective meanings:

24	(3) "Governing authority" means the city of New Orleans or any assignee
25	thereof which is authorized by the municipality to carry out the purpose of this Part,

SB NO. 236 ENROLLED D. In the Parish of East Baton Rouge, notwithstanding any provision of law to the contrary, expropriation proceedings shall be initiated by the member of the governing authority representing the district in which the subject property is located. Section 3. R.S. 33:4761 is hereby amended and reenacted to read as follows: §4761. Condemnation of buildings by all parishes and municipalities **<u>A.</u>** The governing authority of any parish or municipality may condemn and cause to be demolished or removed any building or structure within the parish or municipality when it is in a dilapidated and dangerous condition which endangers the public welfare. B. Notwithstanding any other provision of law to the contrary, in the city of Baton Rouge and parish of East Baton Rouge, the hearing officer appointed pursuant to R.S. 13:2575 and 2576 shall determine condemnations.
