3	and (B), to enact R.S. 37:3286(A)(4) and (E), and to repeal R.S. 37:3286(A)(1)(c)
4	through (f), (2)(c) through (f), and (3)(d) through (k), relative to private contract
5	security companies; to provide for the schedule of certain fees for private contract
6	security companies; to provide the method for payment of fees; to provide for the
7	display of the fee schedule; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 37:3286(A)(1)(a) and (b), (2)(a) and (b), and (3)(a) through (c) and
10	(B) are hereby amended and reenacted and R.S. 37:3286(A)(4) and (E) are hereby enacted
11	to read as follows:
12	§3286. Fees
13	A. The board may assess the following schedule of fees, which shall not be
14	refundable:
15	(1) Company <del>licensee</del> <u>license fees</u> :
16	(a) Application fee - \$20.00 Initial company license - \$500.00.
17	(b) Examination fee - \$50.00 Company license renewal - \$410.00.

19	(2) Registrant Guard registration fees:
20	(a) Application fee - \$30.00 Initial guard registration - \$75.00.
21	(b) Renewal fee - \$30.00 Guard registration renewal - \$65.00.

23	(3) Instructor licensee license fees:
24	(a) Application fee - \$20.00 Classroom instructor license/renewal - \$110.00.
25	(b) In-house/outside classroom license fee - \$100.00 Baton instructor
26	license/renewal - \$130.00.

8	or via electronic payment to the board.

10	E. The board shall display a publicly accessible fee schedule on its website
11	that includes every fee it charges, including administrative fees, and the statutory or
12	regulatory authority for those fees. After complying with the Administrative
13	Procedure Act, the board shall regularly update the fee schedule of any additional
14	regulatory or statutory changes.
15	Section 2. R.S. 37:3286(A)(1)(c) through (f), (2)(c) through (f), and (3)(d) through
16	(k) are hereby repealed in their entirety.
17	Section 3.(A) The fees provided for in R.S. 37:3286(A) as enacted by Section 1 of
18	this Act shall supersede and replace all administrative fees provided for in the Part LIX of
19	Title 46 of the Louisiana Administrative Code upon enactment of this Act.
20	(B) The fees provided for in R.S. 37:3286(A) as enacted by Section 1 of this Act
21	shall not supersede or replace any administrative fees imposed after the enactment of this
22	Act until otherwise provided by law.
