ELECTIONS/DATES EG SEE FISC NOTE Provides for election dates for certain elections in 2026 (Item #1)

Proposed law moves the April 18, 2026, election to May 16, 2026, and moves the May 30, 2026, election to June 27, 2026; provides for date changes for various deadlines including the qualifying period, nominating period, and campaign finance disclosure deadlines; changes the requirement that a portion of qualified signatures for nominating petitions for U.S. Senate and U.S. Representatives candidates comes from within the congressional district to within the state; and provides that any notice, resolution, proclamation, or certification by a local governing authority shall not be invalidated for failure to state the May 16, 2026, or June 27, 2026, election dates.
