HEALTH CARE. Provides relative to the administration of medications. (8/1/26)

1 AN ACT

2 To enact R.S. 40:1133.4(A)(9) and 1133.19, relative to emergency medical services; to  
3 provide for the administration of certain medications; to provide for protocols; to  
4 provide for limitations; to provide for immunity; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 40:1133.4(A)(9) and 1133.19 are hereby enacted to read as follows:

7 §1133.4. Powers and duties of the commission; exceptions

8 A. The commission shall:

10 **(9) Establish protocols to authorize licensed emergency medical**  
11 **technicians, licensed advanced emergency medical technicians, and licensed**  
12 **paramedics to administer patient-carried, time-critical prescription medication,**  
13 **to patients with rare diseases, chronic illnesses, and special medical needs**  
14 **pursuant to R.S. 40:1133.19.**

16 **§1133.19. Administration of patient-carried, time critical medication;**  
17 **authority; liability**

1           A. A licensed emergency medical technician, licensed advanced  
 2           emergency medical technician, or licensed paramedic may administer  
 3           patient-carried, time-critical prescription medication, to patients with rare  
 4           diseases, chronic illnesses, and special medical needs at the request of the  
 5           patient or patient's family and in accordance with protocols established by the  
 6           commission.

7           B. Medications administered pursuant to this Section shall be limited to  
 8           intranasal, intravenous, and intramuscular medications.

9           C. A licensed emergency medical technician, licensed advanced  
 10          emergency medical technician, or licensed paramedic that administers a  
 11          patient-carried, time-critical prescription medication at the request of the  
 12          patient or patient's family member as provided for in this Section shall be  
 13          immune from civil liability, criminal prosecution, or disciplinary or other  
 14          adverse action under any professional licensing statute for any outcomes  
 15          resulting from the administration of the medication, unless personal injury  
 16          results from the gross negligence or willful or wanton misconduct of the  
 17          practitioner administering the medication.

18          Section 2. This Act shall be known and may be cited as "The Danny's Dose EMS  
 19          Treatment Act".

Present law provides for the powers and duties of the La. Emergency Medical Services Commission, including making recommendations to the La. Dept. of Health, bureau of emergency medical services regarding requirements and standards of practice for licensed EMS practitioners.

Proposed law adds a requirement for the commission to establish protocols to authorize certain licensed EMS practitioners to administer patient-carried, time-critical prescription medication to patients with rare diseases, chronic illnesses, and special medical needs.

Proposed law authorizes the EMS practitioners to administer the medication at the request of the patient or patient's family and in accordance with protocols established by the

commission.

Proposed law provides that an EMS practitioner acting in accordance with the provisions of proposed law shall be immune from civil liability, criminal prosecution, or disciplinary or other adverse action under any professional licensing statute for any outcomes resulting from the administration of the medication, unless personal injury results from the gross negligence or willful or wanton misconduct of the EMS practitioner administering the medication.

Proposed law provides that proposed law shall be named and may be known as "The Danny's Dose EMS Treatment Act".

Effective August 1, 2026.
