SENATE BILL NO. 241

BY SENATOR HODGES

INSURANCE DEPARTMENT. Requires the inclusion of the license number of adjusters, appraisers, and contractors in all written communications. (8/1/26)

1 AN ACT

2 To enact R.S. 22:1674.1(A)(22), 1706(H)(12), and 1807.16(D)(5) and R.S. 37:2156.1(K),
3 relative to requiring the inclusion of certain licensing numbers in written
4 communications; to regulate insurance adjusters, public adjusters, insurance
5 appraisers, and contractors; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 22:1674.1(A)(22), 1706(H)(12), and 1807.16(D)(5) are hereby
8 enacted to read as follows:

9 §1674.1. Standards of conduct; acknowledgment required

10 A. The following standards of conduct shall be binding on all claims
11 adjusters:

13 **(22) An adjuster shall include his Louisiana license number in all written**
14 **communications, including electronic communications, composed and sent as**
15 **part of his business or employment.**

17 §1706. Standards of conduct of public adjuster

2 H. Public adjusters shall also adhere to all of the following general
3 requirements:

5 **(12) A public adjuster shall include his Louisiana license number in all**
6 **written communications, including electronic communications, composed and**
7 **sent as part of his business or employment.**

9 §1807.16. Appraiser obligations

11 D. An appraiser has a duty to do all of the following:

13 **(5) Include his Louisiana license number in all written communications,**
14 **including electronic communications, composed and sent as part of his business**
15 **or employment.**

17 Section 2. R.S. 37:2156.1(K) is hereby enacted to read as follows:

18 §2156.1. Requirements for issuance of a license

20 **K. A contractor shall include his Louisiana license number in all written**
21 **communications, including electronic communications, composed and sent as**
22 **part of his business or employment.**
