DISTRICT ATTORNEYS/ASST: Provides for an increase in the dollar amount in warrants to provide for the salaries of assistant district attorneys

1 AN ACT

2 To amend and reenact R.S. 16:11(A)(1), relative to the annual salary of assistant district
3 attorneys paid by the state; to provide for an increase in the annual salary of assistant
4 district attorneys paid by the state; to provide for an effective date; and to provide for
5 related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 16:11(A)(1) is hereby amended and reenacted to read as follows:

8 §11. Annual salary of assistant district attorneys payable by state

9 A.(1) Except as provided in Paragraph (2) of this Subsection, effective July
10 1, 2006, the annual salary of each of the several assistant district attorneys
11 throughout the state of Louisiana, including the parish of Orleans, is hereby fixed at
12 thirty-five thousand dollars payable monthly by the state treasurer upon the warrant
13 of each of the assistant district attorneys. Effective July 1, 2007, the annual salary
14 of each of the several assistant district attorneys; throughout the state of Louisiana,
15 including the parish of Orleans, is hereby fixed at forty thousand dollars payable
16 monthly by the state treasurer upon the warrant of each of the assistant district
17 attorneys. Effective July 1, 2008, the annual salary of each of the several assistant
18 district attorneys; throughout the state of Louisiana, including the parish of Orleans,
19 is hereby fixed at forty-five thousand dollars payable monthly by the state treasurer
20 upon the warrant of each of the assistant district attorneys. Effective July 1, 2020,

1 the annual salary of each of the several assistant district attorneys throughout the
2 state of Louisiana, including the parish of Orleans, is hereby fixed at forty-seven
3 thousand five hundred dollars payable monthly by the state treasurer upon the
4 warrant of each of the assistant district attorneys. Effective July 1, 2021, the annual
5 salary of each of the several assistant district attorneys throughout the state of
6 Louisiana, including the parish of Orleans, is hereby fixed at fifty thousand dollars
7 payable monthly by the state treasurer upon the warrant of each of the assistant
8 district attorneys. Effective July 1, 2026, the annual salary of each of the several
9 assistant district attorneys throughout the state of Louisiana, including the parish of
10 Orleans, is hereby fixed at fifty thousand five hundred dollars payable monthly by
11 the state treasurer upon the warrant of each of the assistant district attorneys. Any
12 increase in salary shall be subject to an appropriation for that purpose.

Abstract: Increases the salary of assistant district attorneys on July 1, 2026.

Present law provides that, effective July 1, 2021, assistant district attorneys statewide are to receive an annual salary of \$50,000 payable monthly.

Proposed law increases the salary of the assistant district attorneys to \$50,500 beginning July 1, 2026.

Effective July 1, 2026.
