REAPPORTIONMENT/SENATE: Provides for the districts for the election of members of the Senate

1 AN ACT

2 To enact R.S. 24:35 and to repeal R.S. 24:35.1, relative to legislative redistricting; to provide
3 for the election districts for the Senate of the Legislature of Louisiana; to provide for
4 effective dates; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 24:35 is hereby enacted to read as follows:

7 §35. Membership of the Senate

8 The Senate of the Legislature of Louisiana shall be composed of thirty-nine
9 members. The state shall be divided into the following senatorial districts and one
10 senator shall be chosen from each of the districts:






Senate - Statewide HLS 26RS-1036 (Jordan)




Senate - Northwest HLS 26RS-1036 (Jordan)




Senate - Central HLS 26RS-1036 (Jordan)




Senate - Southwest HLS 26RS-1036 (Jordan)






