6 all violations in a calendar year per insurer, person, or entity, ~~when~~ if such violations"7 AMENDMENT NO. 3

8 On page 2, delete line 15 in its entirety and insert in lieu thereof the following:

9 "and up to ~~one~~ five hundred thousand dollars aggregate for all violations in a
10 calendar"11 AMENDMENT NO. 4

12 On page 2, at the beginning of line 16, insert "year."

13 AMENDMENT NO. 5

14 On page 2, delete lines 27 and 28 in their entirety and insert in lieu thereof the following:

15 "per health insurance issuer, up to ~~one~~ five hundred thousand dollars aggregate for
16 all violations in a calendar year per health insurance issuer, ~~when~~ if such violations, in"17 AMENDMENT NO. 6

18 On page 3, between lines 5 and 6, insert a set of asterisks "****"

19 AMENDMENT NO. 7

20 On page 3, delete lines 9 and 10 in their entirety and insert in lieu thereof the following:

21 "for each violation. No fine or fines shall be imposed against a lessor, pursuant to this
22 Section, which aggregates in excess of ~~ten~~ fifty thousand dollars in any calendar year."23 AMENDMENT NO. 8

24 On page 3, delete lines 15 and 16 in their entirety and insert in lieu thereof the following:

25 "exceed five hundred dollars for each violation occurring, up to ~~ten~~ fifty thousand
26 dollars aggregate for all violations in a calendar year per applicant or licensee, or any"27 AMENDMENT NO. 9

28 On page 3, delete lines 22 and 23 in their entirety and insert in lieu thereof the following:

29 "not to exceed five hundred dollars for each violation up to ~~ten~~ fifty thousand dollars
30 aggregate for all violations in a calendar year, unless a fine is established by separate"31 AMENDMENT NO. 10

32 On page 4, delete line 2 in its entirety and insert in lieu thereof the following:

1 "up to ~~one~~ five hundred thousand dollars in the aggregate for all violations in a
2 calendar"

3 AMENDMENT NO. 11

4 On page 4, at the beginning of line 3, insert "year"

5 AMENDMENT NO. 12

6 On page 4, delete lines 9 and 10 in their entirety and insert in lieu thereof the following:

7 "fine not to exceed five hundred dollars for each violation occurring, up to ~~ten~~ fifty
8 thousand dollars aggregate for all violations in a calendar year per applicant or"
