Subject: Reinstatement fees for suspended licenses

FEES/LICENSES/PERMITS EG +\$280,400 SG RV See Note Page 1 of 1
 Provides relative to reinstatement fees for certain offenses assessed by the office of motor vehicles

Proposed law provides for increases in reinstatement fees for suspended licenses based on operating a motor vehicle while under the influence of alcoholic beverages or narcotics drugs. Proposed law changes the reinstatement fee for a first offense from \$100 to \$200, for a second offense from \$200 to \$400, and for any subsequent offense from \$300 to \$600.
