Subject: Nondisclosure Agreements - Victims of Child Sex Abuse		

SEX OFFENSES OR NO IMPACT See Note Page 1 of 1
Provides that nondisclosure agreements involving victims of child sexual abuse are against public policy and unenforceable. (8/1/26)

Proposed law provides that no agreement involving a victim of child sexual abuse that prevents, or has the effect of preventing, the victim from disclosing or discussing the abuse involving the victim is judicially enforceable, and is null and void as against public policy.

EXPENDITURE EXPLANATION


