DISTRICTS/WATER CONSERVN RE DECREASE LF EX See Note Page 1 of 1  
 Provides for the election, duties, and requirements of district supervisors of the soil and water conservation commission

Present law authorizes the Soil and Water Conservation Commission to conduct elections to elect district supervisors for the commission. Proposed law transfers election oversight of district supervisors for the commission to the Secretary of State, modifies supervisor terms, vacancy procedures, and attendance requirements for reappointment or reelection of district supervisors.

**EXPENDITURE EXPLANATION**

Proposed law may decrease local expenditures for the Soil and Water Conservation’s individual districts. Proposed law transfers election oversight of district supervisors from the Soil and Water Conservation Commission to the Secretary of State (SOS).

Louisiana has 44 Soil and Water Conservation Districts. Each district is governed by a board of five supervisors, three of whom are elected and two of whom are appointed by the commission. Elected supervisors serve three-year terms and are elected annually in June on a rotating basis. LDAF reports that, in most cases, an election is not required, as most districts historically have had one person running unopposed.

Currently, in the event an election is required, these districts cover the costs to conduct the election. LDAF estimates that the costs to the districts is typically between \$800 and \$3,500 per election, depending on the number of parishes in the district.

The SOS currently provides private elections and passes any costs to the entity for which the election is held, through fees charged for voting machine rentals and ballot preparations. The SOS does not anticipate any expenditures to implement the proposed law, as the costs to conduct the election will be passed on to the individual Soil and Water Conservation Districts.

In the event of an election, the Soil and Water Conservation District would be required to pay the SOS to rent voting machines and prepare ballots. The SOS reports that each machine required to be rented costs \$100, and has a two machine minimum per location. Additionally, the SOS provides that each ballot style configuration costs \$100 each. This would result in a minimum cost of \$300 for each election conducted. The actual cost will depend on how many voting locations will be needed per districts, which will depend on the number of parishes in the district. This may result in a decrease in local expenditures required for each election conducted.

**REVENUE EXPLANATION**

Proposed law may increase revenues deposited into the statutorily dedicated Voting Technology Fund. Proposed law transfers election oversight of district supervisors for the Soil and Water Conservation Commission to the Secretary of State (SOS). The SOS reports that each machine required to be rented costs \$100, and has a two machine minimum per location, and a \$100 fee for ballot configuration. LDAF reports that these elections are rare, as candidates typically run unopposed. To the extent elections for these districts occur, there will be an indeterminable increase in revenue for SOS.
